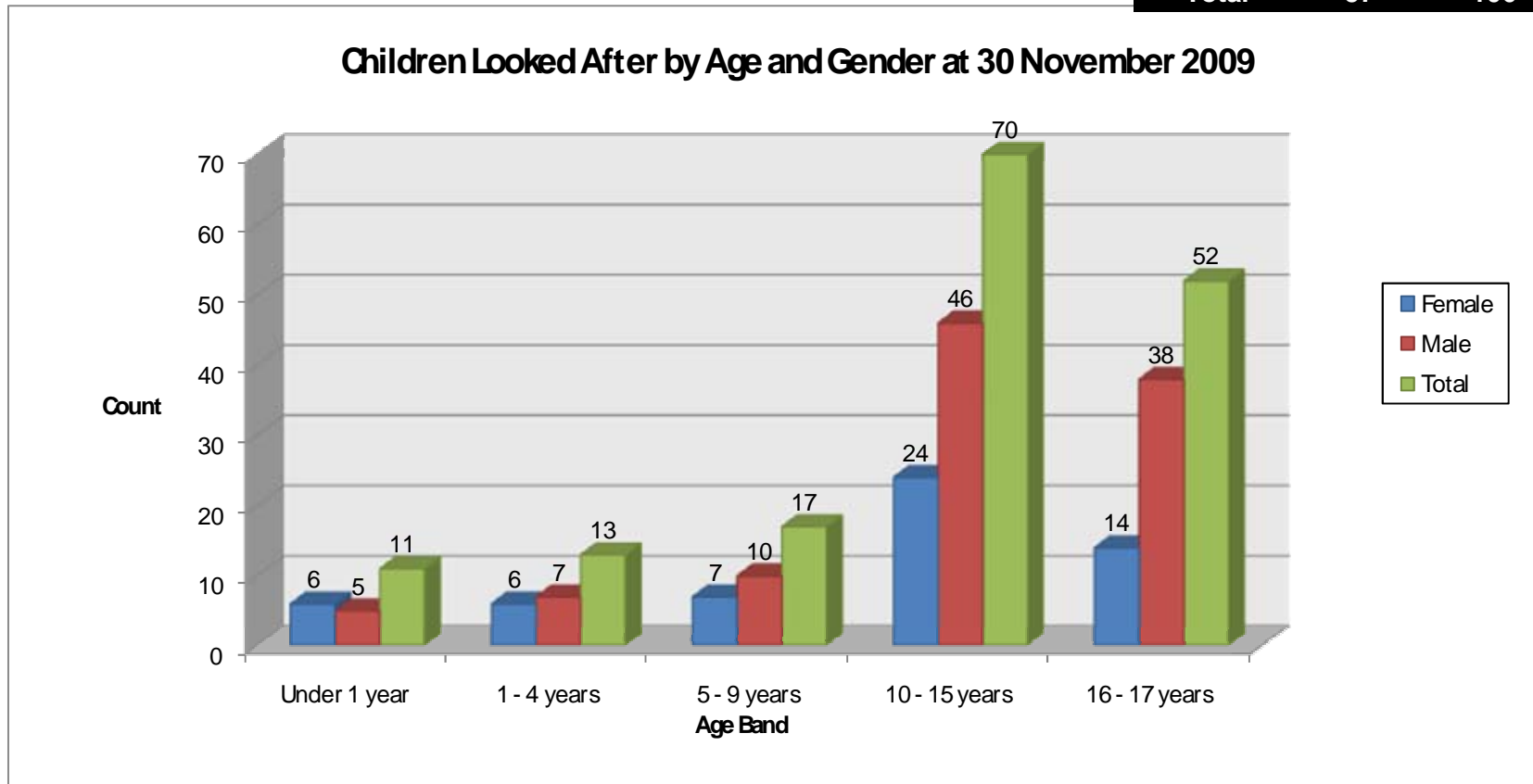

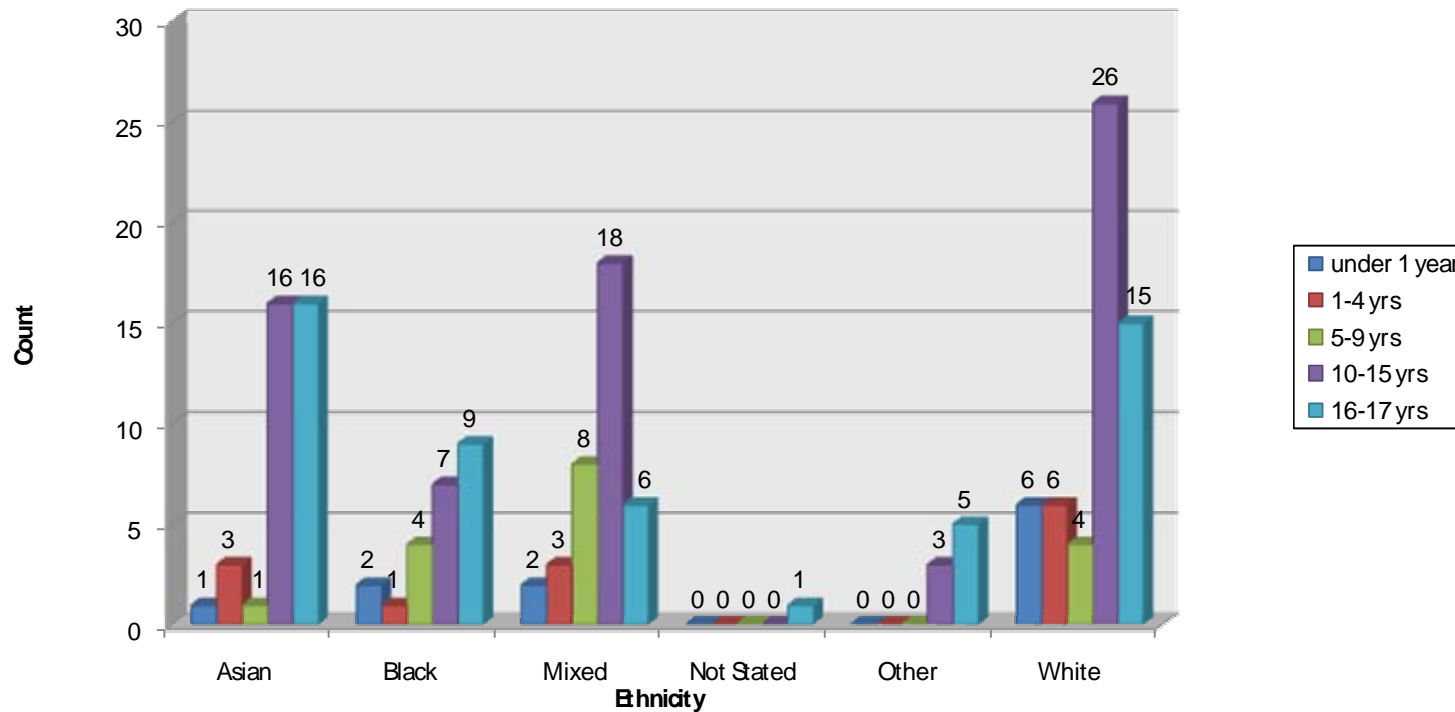

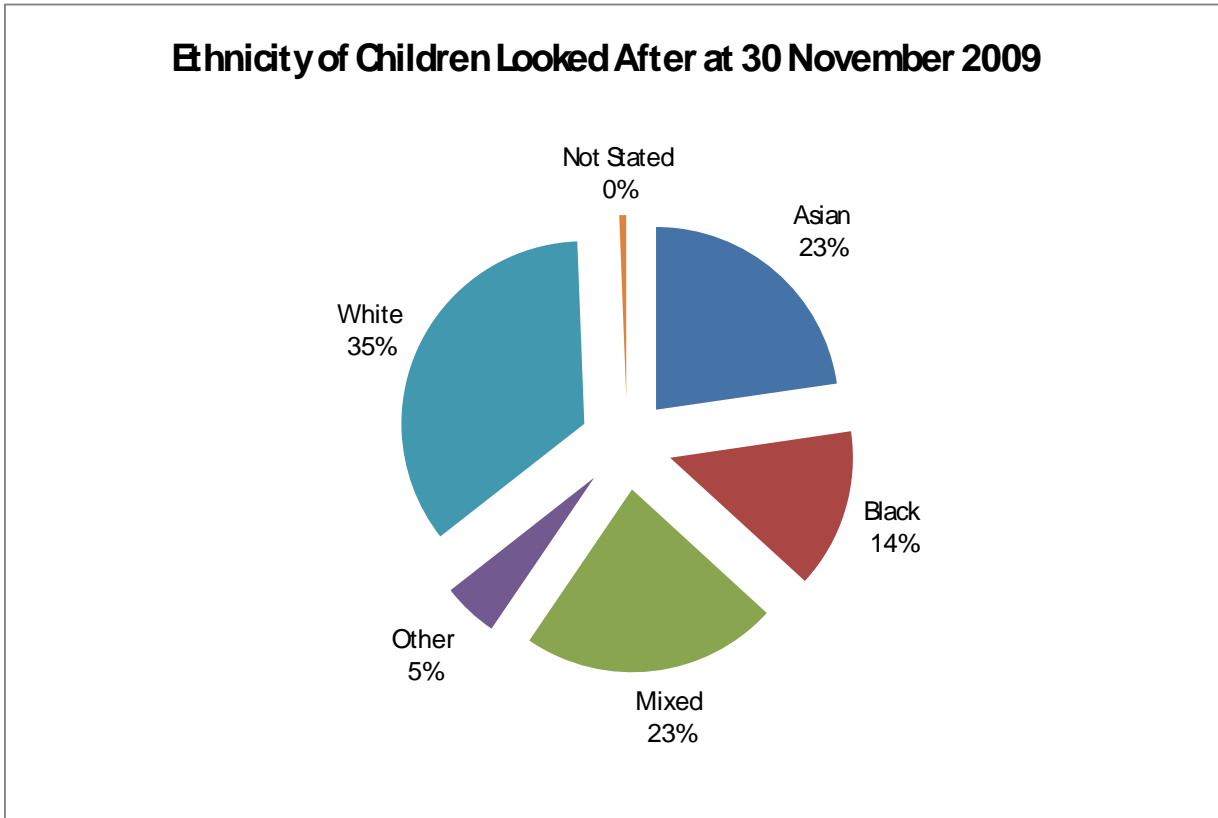

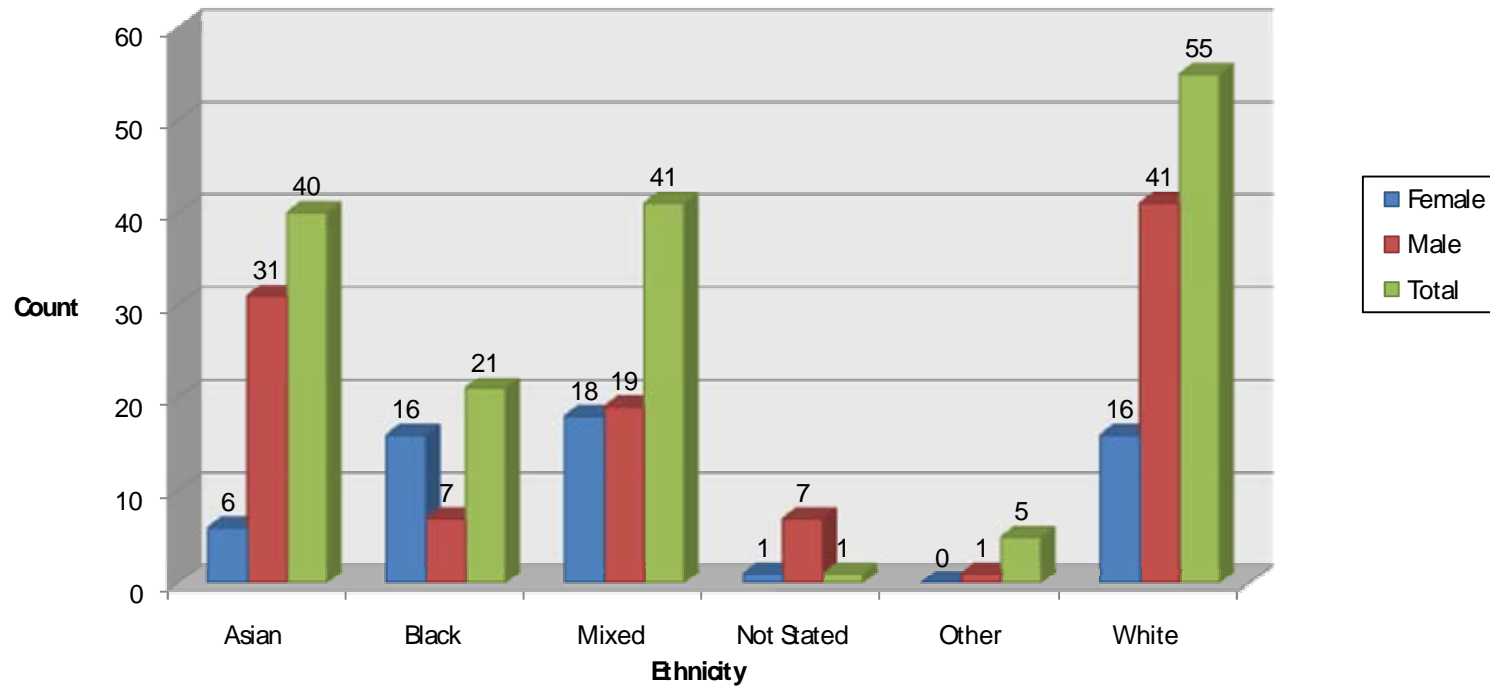

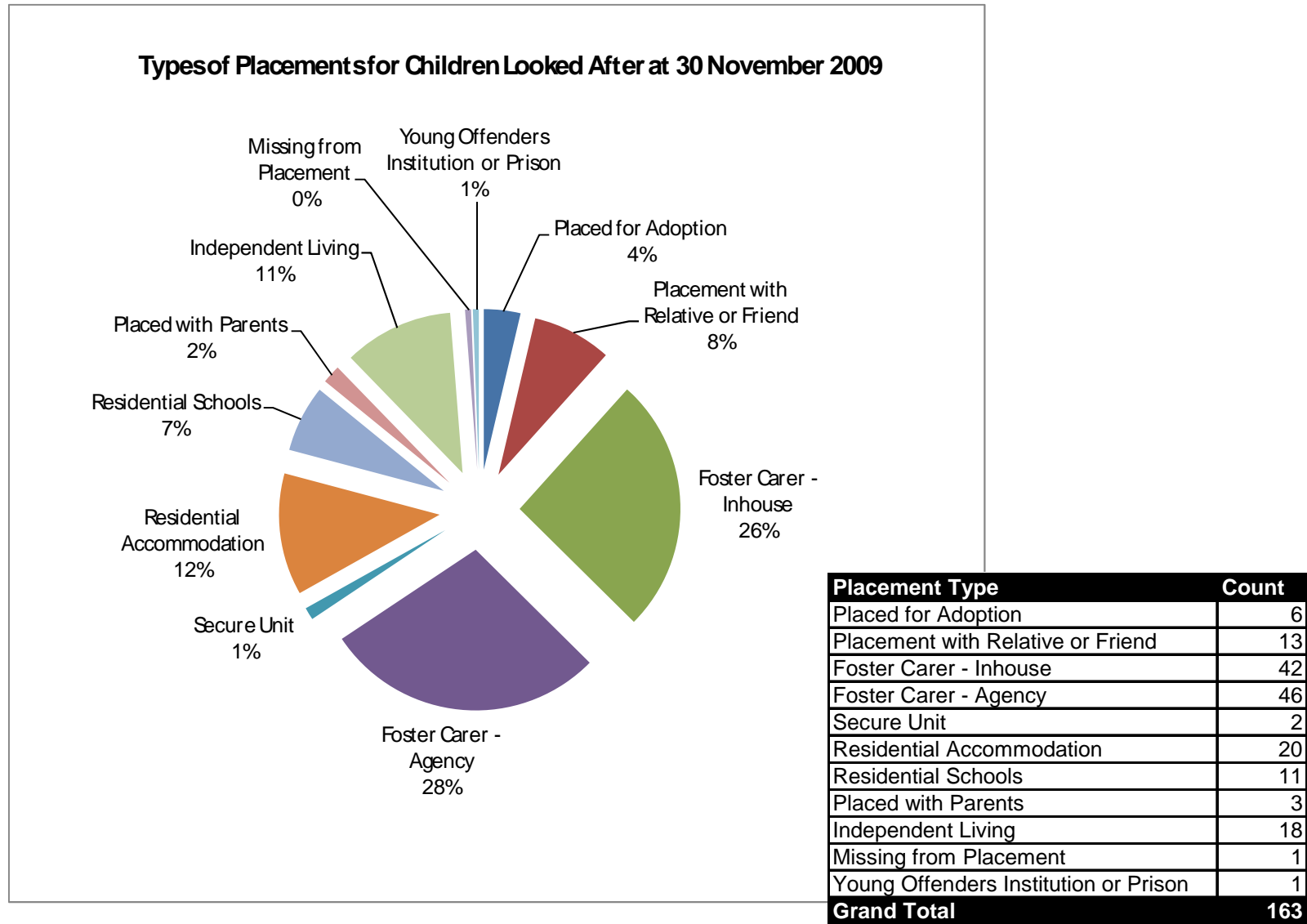

**Children Looked After by Ethnicity and Gender at 30 November 2009**



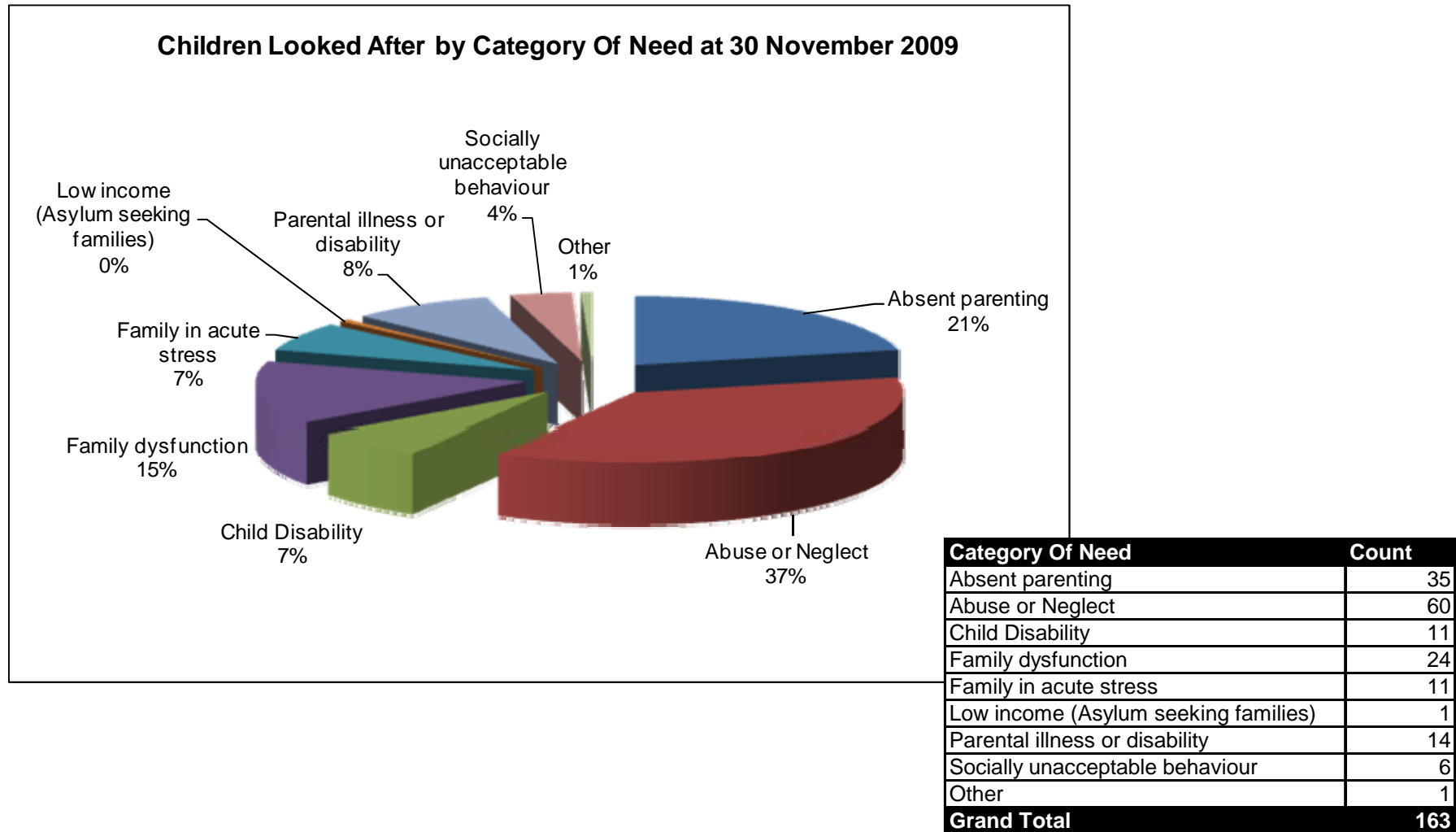

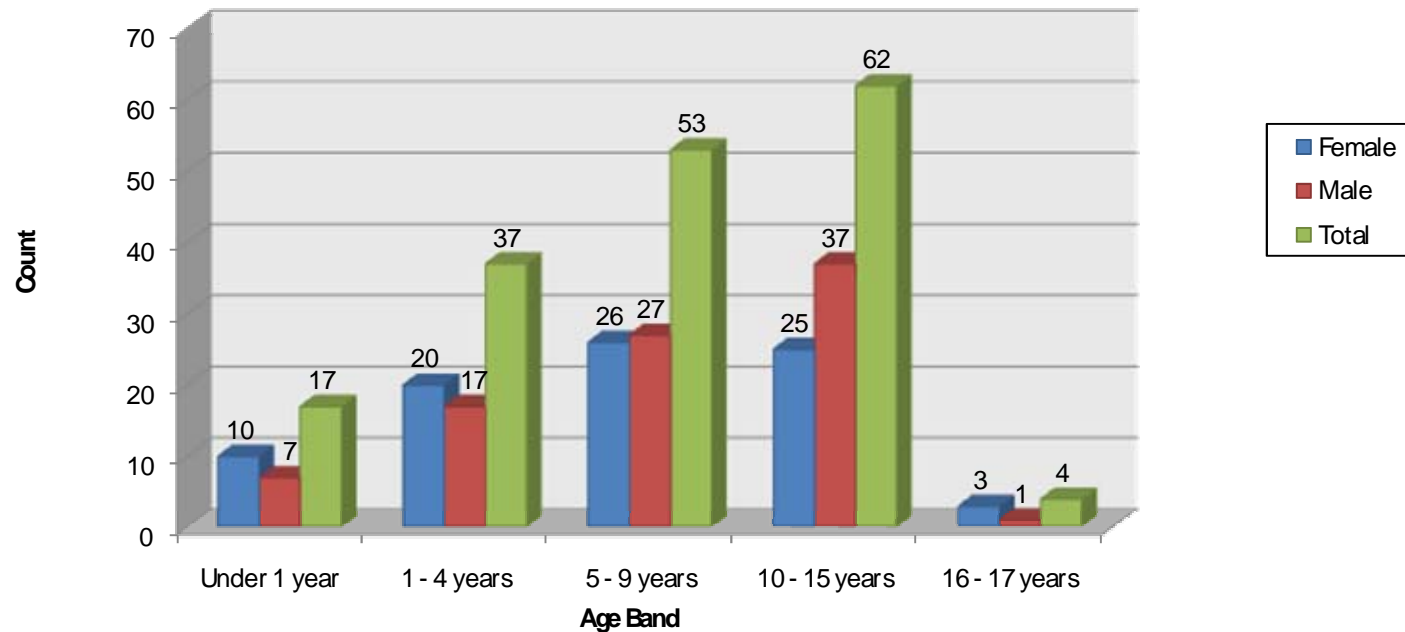

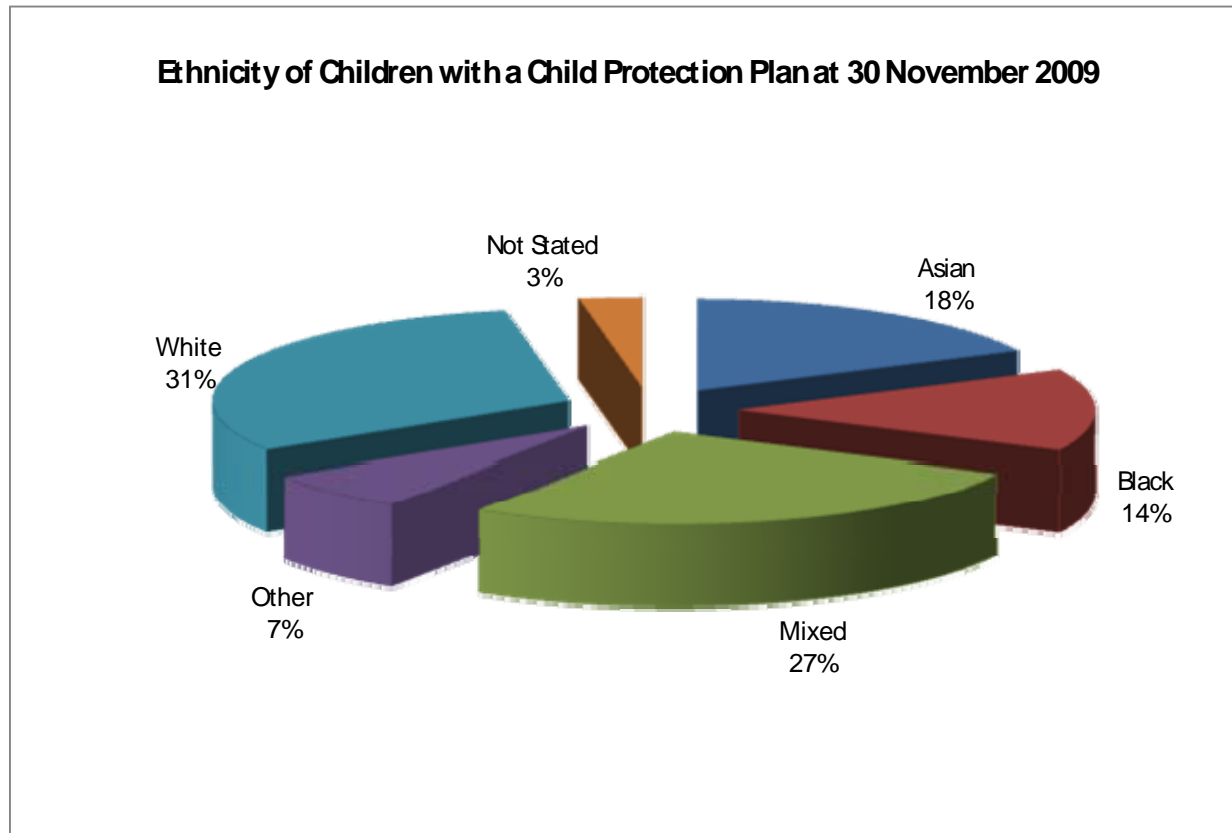

**Children with Child Protection Plans by Age and Gender at 30 November 2009**



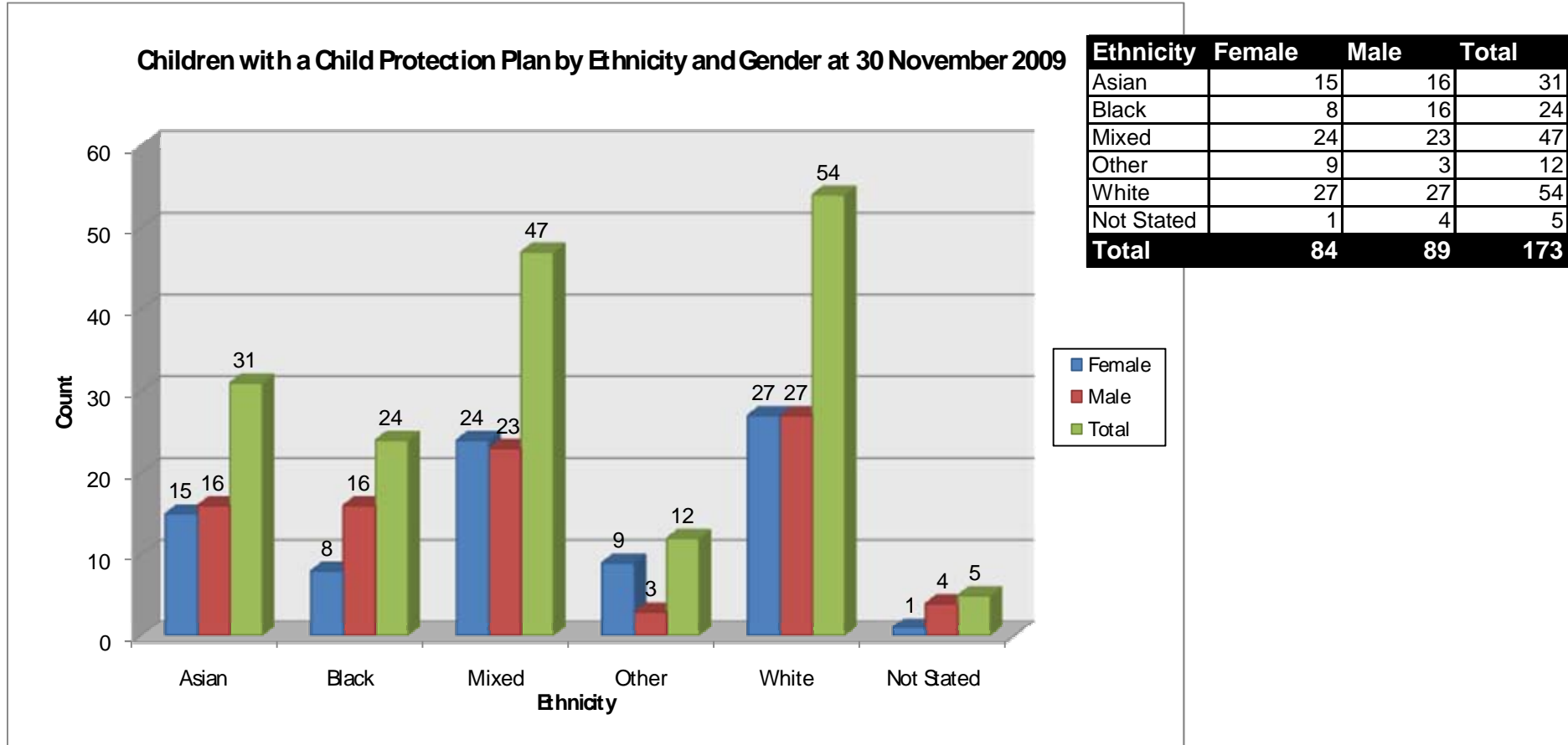

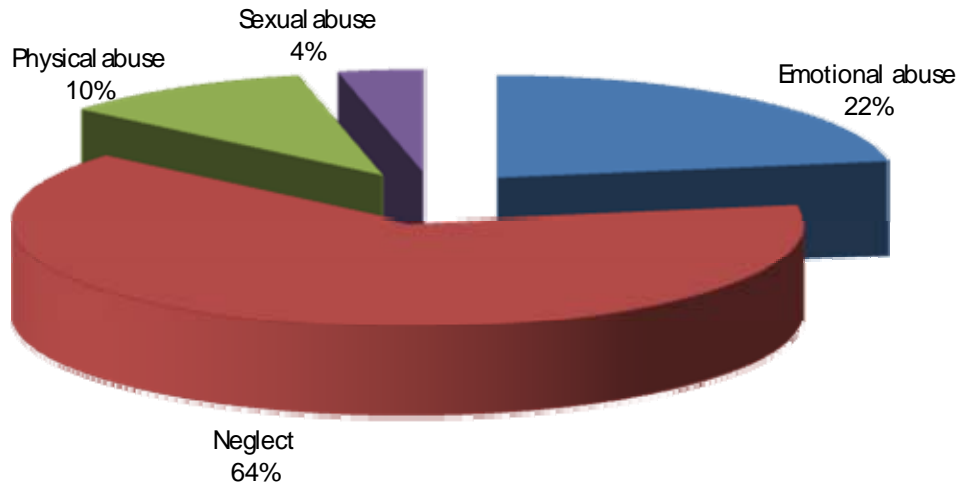

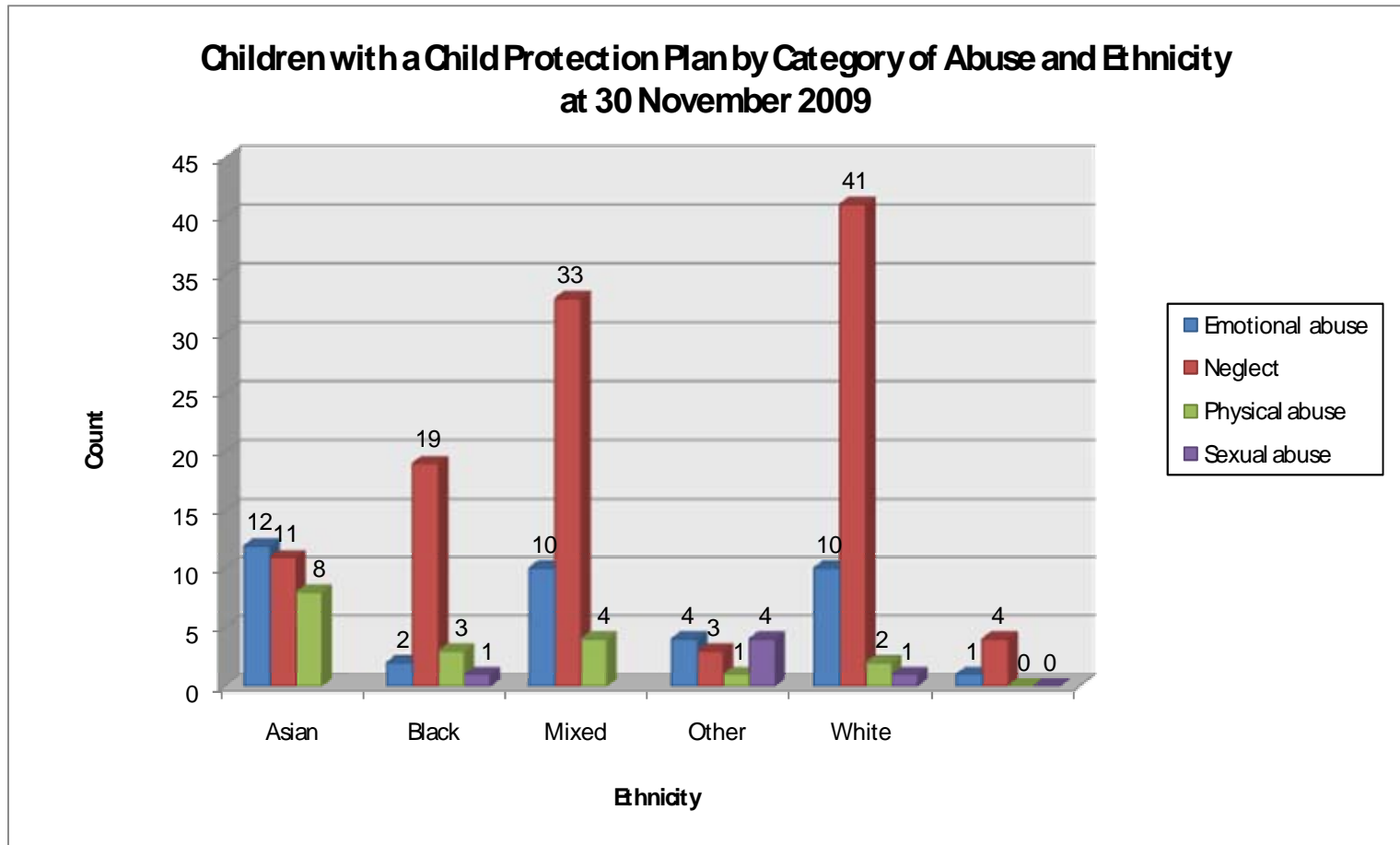

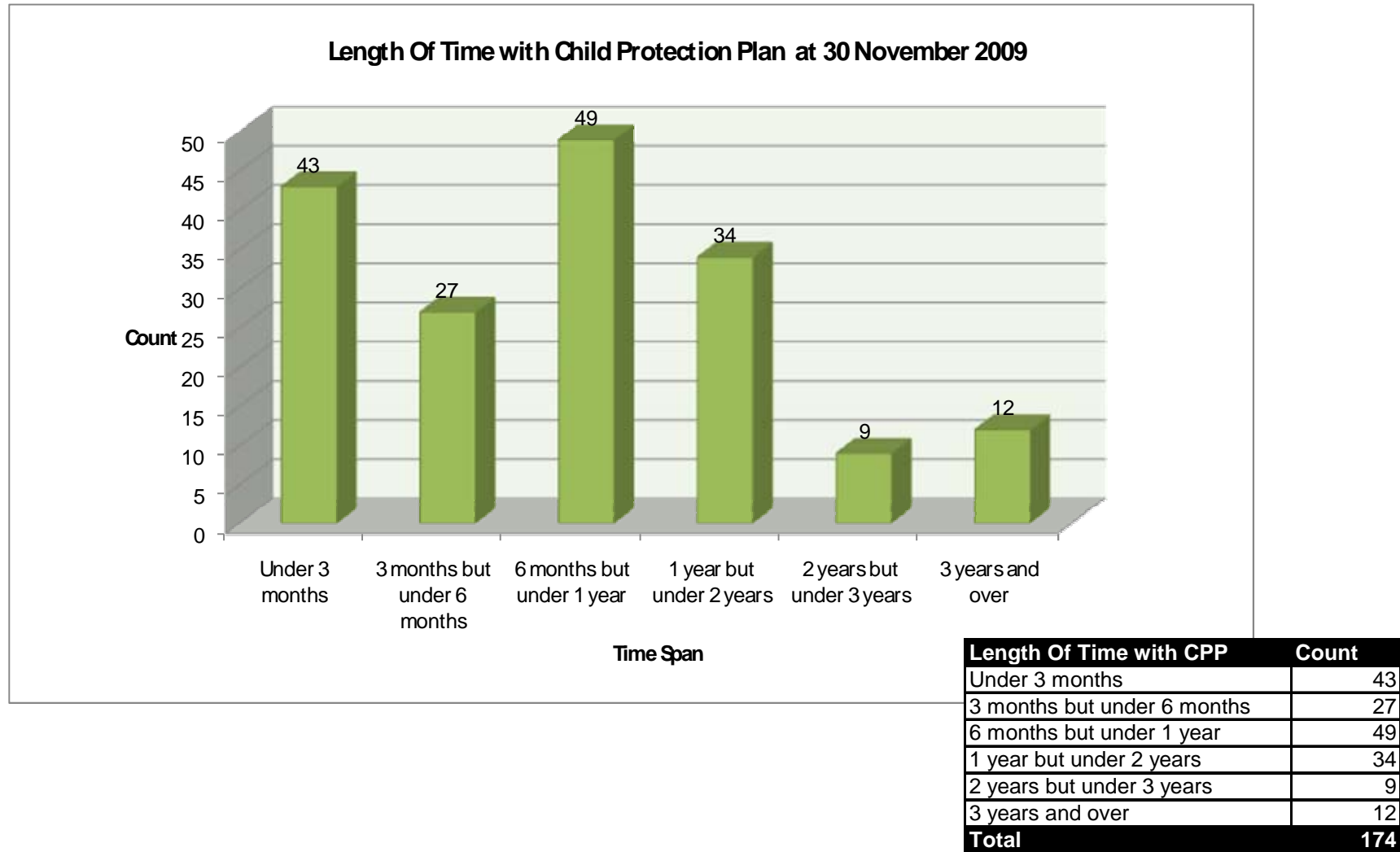

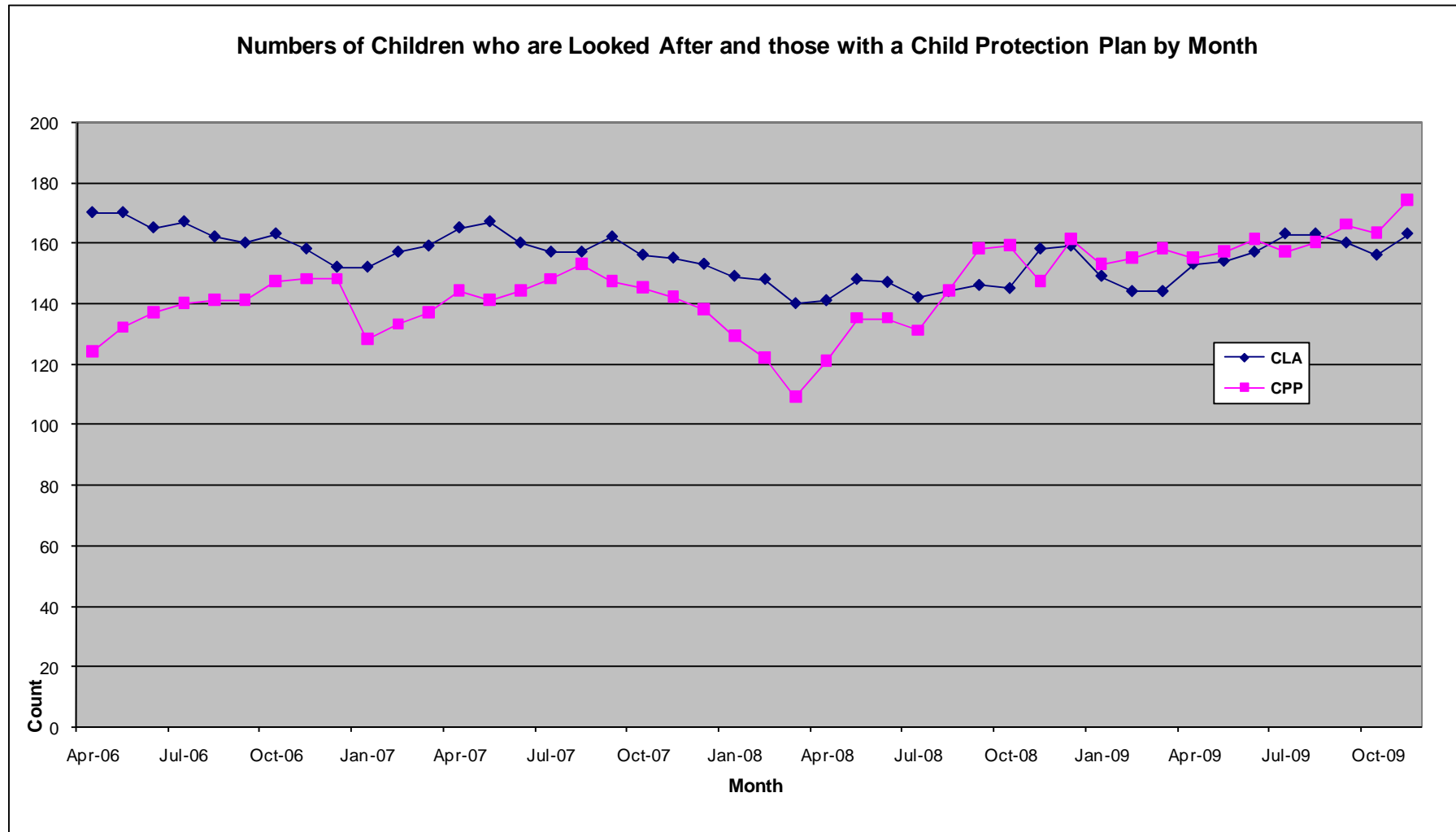
