The programme is also subject to change depending on other council decisions, such as whether there is Scrutiny Committee "call-in", referrals to Council Cabinet, other priorities, workload and available resources as they emerge during the year.

All reviews will consider the need for on street business permits with the exception of Harrow Town Centre.
