Section 2 – Report

Introductory paragraph

1. This report sets out proposals to transfer funds between budgets to enable investment in service priorities.

Options considered

Pot holes

- 2. The extremely bad weather during the winter has caused considerable damage to the borough's roads and pavements. This is a key concern of residents. Investment to repair some of the damage is now urgently required.
- 3. It is therefore proposed that £150k is transferred from a number of budgets within the Community and Environment Directorate, where an underspend is currently forecast, to invest in highways.
- 4. This amount would help alleviate the current acute situation, giving the opportunity to fully assess the extent of the past two winters' damage. In real terms this money could repair up to 2000 of the most critical potholes.

Transformation Programme

- 5. In July 2009, Cabinet received a report on the Better Deal for Residents programme. This programme is the Council's response to the need to meet the rising expectations of residents whilst recognising the constraints on public funds. The programme has five workstreams:
 - Cross Council Efficiency Review
 - Better Together
 - Future Operating Model
 - Service Efficiency Programme
 - Place Shaping and Property
- 6. The programme is progressing well, and is now entering the next phase, which includes, for instance, the development of business cases for some of the Council's back office functions. The intention is to be in a position to give advice and a range of options to the incoming administration after the local elections in May.
- 7. Funding is required to develop and support the programme, including professional fees and specialist advice. The sum of £200k has been identified from the creditors control account on the Council's balance sheet essentially this account holds sums where purchase orders have been raised but not fully utilised, and the account is cleared down at regular intervals as part of the council's financial control environment.

Free Personal Care

- 8. Cabinet is also reminded that, as part of the third quarter monitoring report received in February, it was recommended that a new earmarked reserve of £250k should be created for free Adult personal care, to cover the additional costs in 2010-11 which the Council believes have been left unfunded by central government.
- 9. Formal decisions on the use of underspends in the current year will be built into the outturn report to June cabinet.
- 10. In the meantime, Cabinet is asked to approve the following virements:

15. Delivery of the Better Deal for Residents Programme will be critical to maintaining the current rate of improvement in Council performance
