Extension of Edgware Controlled Parking Zone (CPZ)

Following the public consultation carried out in October 2003, it has been decided to implement a scheme in the area shown on the enclosed plan. This would be subject to the statutory traffic order making (legal) process, which includes consideration of objections (if any). The scheme would operate for one hour a day (11 am to 12 noon), Monday to Friday.

The consultation responses from Handel Close were 7 in favour and 6 against a CPZ. A petition containing 9 signatures from Handel Close was also received opposing the scheme. In view of the conflicting messages, it was decided to re-consult the Handel Close residents at the order making stage. This process will commence on 10 June.

If the majority of Handel Close respondents to this consultation indicate a preference for being excluded from the scheme, the road will be removed from the proposals. A detailed plan of the proposals for Handel Close is also attached.
