Section 2 - Report

Background

Harrow GP Out-Of-Hours Service

Earlier in March 2010, it came to light that the GP out-of-hours service in Harrow was rated sixth worst in the country and almost a fifth of patients who use the GP services rated it "poor" or "very poor" according to figures obtained by the Patients Association (investigation attached appendix A). The survey followed the death, in 2008, of David Gray, who died following treatment by a German doctor with no experience as an NHS GP but was covering out-of-hours service.

Following news of the poor results, the adult health and social care leads at the time then wrote to NHS Harrow, raising their concerns about the out-of-hours service (attached in appendix B). This was followed by a response from the former Chair of NHS Harrow at the time, Dr Sarah Crowther (attached in appendix C).

On 18 November, the Chairman of the Health sub-committee and health leads met with the Chairman of NHS Harrow to get an update on the progress with regards to the GP out-of-hours service. The Chair of the health sub-committee and the health leads were informed that they were due to meet with Harmoni who held the out-of-hours contract with NHS Harrow on 19 November and so were unable to update them on progress at the time.
