We the undersigned object to the installation of a 12.5m high telecommunications monopole mast and ancillary radio equipment cabinet adjacent to 86 Dalkeith Grove, Stanmore HA7 4SF and ask the Council to reject the siting and appearance of the development.

We object on the following grounds:

The danger to the School community, its staff, parents, pupils and residents as the mast would be in close proximity to North London Collegiate First, Junior and Senior School and in close proximity to Aylward Nursery, Infant and Junior School. There is growing evidence that mobile phone masts could have a negative impact upon public health.
