Section 1 – Summary and Recommendations

This report sets out proposed amendments to paragraph 30 of the Council's Committee Procedure Rules in relation to information on the rights of Applicants, Objectors and Members to speak in relation to Applications at the Planning Committee.



Recommendations:

That the Committee note and comment on the proposed changes to paragraph 30 of the Council's Committee Procedure Rules in relation to information on the rights of Applicants, Objectors and Members to speak in relation to Applications at the Planning Committee as contained in Appendix A.

Section 2 - Report

Background

Paragraph 30 of the Council's Committee Procedure Rules details rights for applicants and objectors to speak in relation to planning applications submitted to the Planning Committee. It relates to applications which are being recommended for grant or approval by the Chief Planning Officer or applications for prior approval of the siting and appearance of telecommunications development where the Chief Planning Officer is recommending that prior approval be not required or that prior approval be required and granted. The Procedure Rules detail the procedure and the time allowed for representations.

Current situation

The Constitution enables Councillors who are not ordinary members or attending Reserve Members of the Committee to speak at meetings if the Committee agrees that the Member concerned may speak or the Member has been invited to the Committee to speak. There is currently no limit on the number of Members who can speak at the Planning Committee nor the length of time for each speech.

Why a change is needed

The proposal is that the number of Members, who are not Members of the Committee, that could speak with the agreement of the Committee should be limited to three, who could each speak for a maximum of five minutes. This should provide clarity for Members and enable a greater opportunity for objectors to address the meeting.

Other options considered

The alternative would be to continue with the present system whereby the Constitution does not limit the number of backbenchers who can speak with the agreement of the Committee, nor the amount of time given to each such Member.
