## **Section 1 – Summary and Recommendations**

## **Section 2 – Report**

#### Introductory paragraph

- **2.1** The Calendar of Meetings provides the framework for the Council's democratic processes.
- 2.2 It is established practice for the Authority's Calendar of Meetings for the succeeding Municipal Year to be the subject of consideration and agreement at this time of the year.
- 2.3 The draft Calendar for 2012/13 follows the pattern established for 2011/12 where possible, other than those changes which are necessary as a result of public holidays, school terms, and religious festivals.
- 2.4 The Calendar makes no specific allowance for Members' commitments at the annual national party conferences or the Local Government Association General Assembly and Conference. However, as in previous years, the relevant dates in 2012 as indicated on the Calendar are:
  - (i) Liberal Democrat Party Conference: 22 26 September 2012
  - (ii) Labour Party Conference: 30 September 4 October 2012
  - (iii) Conservative Party Conference: 8 12 October 2012
- 2.5 The Calendar also identifies to assist Members dates proposed for Political Group meetings and Member Development events, although these are not open to the public and do not constitute a formal part of the committee programme.
- **2.6** A draft of the proposed Calendar for the Municipal Year 2012/13 was provided to the Conservative Group in advance of this meeting.
  - Unison and GMB have also been provided with the draft dates for meetings of the Employees' Consultative Forum.
