Annex 1 – Mandatory Conditions

Mandatory conditions where licence authorises supply of alcohol:

- 1 No supply of alcohol may be made under the premises licence
 - a) at a time when there is no designated premises supervisor in respect of the premises licence, or
 - b) (b) at a time when the designated premises supervisor does not hold a personal licence or his personal licence is suspended
- 2. Every supply or sale of alcohol made under the premises licence must be made or authorised by a person who holds a personal licence.

Mandatory conditions where licence authorises exhibition of films:

- (1) The admission of persons under the age of 18 years to exhibitions of films must be restricted in accordance with any recommendation made by the British Board of Film Classification, except where condition 2 applies.
- (2) The admission of persons under the age of 18 years to exhibitions of films must be restricted in accordance with any recommendation made by the relevant licensing authority regarding the film in question

Mandatory condition where licence requires door supervision:

Where one or more individuals are required to be at the premises to carry out a security activity, such individual(s) must be licensed by the Security Industry Authority.





Annex 2 - Conditions consistent with the operating Schedule

- 1. CCTV will be installed, operated and maintained according to the reasonable specification of the Metropolitan Police Crime Prevention Officer before the licence becomes effective: images will be securely stored, kept for a minimum of 31 days and made available to officers of the police or local authority upon request.
- 2. Prior to the licence becoming effective, a monitored Central Station Alarm will be installed, operated and maintained according to the reasonable specification of the Metropolitan Police Crime Prevention Officer.
- 3. Qualified door staff will be deployed at busy times.
- 4. The premises will adopt a zero tolerance policy towards drug use and will report offenders to the relevant authorities.
- 5. All fire safety equipment will be operated and maintained to the reasonable specification of the local fire authority
- 6. Fire exits will be clearly signed and kept clear of obstruction at all times.
- 7. Drinking outside the premises will not be allowed.
- 8. Signs will be placed at all exits requesting that patrons respect the needs of local residents and leave the premises and area quietly.
- 9. Deliveries will only be accepted during daytime hours.
- 10. The premises will operate a 'Challenge 21' policy, whereby any person wishing to purchase alcohol, and who appears to under the age of 21 years, will be asked to provide proof (i.e. passport, driving licence or other such accredited form of photo identification) that they are over 18 years of age: notices will be posted advising patrons that such a scheme is being operated and a record of age related refusals of sale will be kept and be made available to officers of the police or local authority upon request.
- 11. No persons under the age of 18 years will be allowed on the premises unless accompanied by a responsible adult and will also not be permitted to consume alcohol on the premises.

Annex 3 - Conditions attached after a hearing by the licensing authority.

1. Noise and vibration shall not be permitted to emanate from the premises so as to cause nuisance to nearby properties.
