Section 1 – Summary and Recommendations

This report sets out the findings of the review of private rented sector housing in Harrow.

Recommendations:

Section 2 – Report

Introduction

The attached report outlines the findings of the review of private rented sector housing in Harrow.

This review originally came to the attention of the Overview and Scrutiny Committee in summer 2011. The Divisional Director, Housing Services, was keen for scrutiny to consider ways in which the council might work in partnership with the Private Rented Sector (PRS) in future, in the context of the growth of the sector in providing housing for residents.

The Overview and Scrutiny Committee agreed to commission a piece of work to examine quality and standards in the PRS and how these might be improved. The review has proved to be particularly timely as the council is in the process of developing a Private Sector Strategy, for consideration by Cabinet in October 2012. The review group hopes that the report goes some way to helping to inform and shape the emergent policy objectives.

Recommendations for the committee

The Committee is requested to agree the report of the review group and to refer the report to Cabinet in September 2012.

At the time of preparing the report, the results of review group's survey of private tenants were not complete. The review group proposes that these results be appended to the review group's report prior to submission to Cabinet. We would like to offer this information to the housing division as an additional source of evidence to help inform strategy development.

In undertaking this review, the group has been struck by the far-reaching scope of the policy area. Our work has touched on a range of related policy areas including strategy for capital. As such, the review group recommends that the Budget Review consider the policy objectives of the Private Sector Strategy as part of its work in reviewing the council's use of capital.
