

#### 1/02 Add:

Condition 7 'The use hereby permitted shall not be open to the public or patients outside of the following times:- 0800 to 2000 Monday to Saturday inclusive and at no other time except with the written permission of the local planning authority.'

REASON To safeguard the amenities of the locality.

#### 1/04 Delete Condition 20

Insert new Condition 20 as follows

'The hotel bedrooms and common areas shall be used for no other purpose nor shall the conference facility internal floor area be increased without the prior written consent of the local planning authority.'

REASON IN the interests of neighbouring amenity.
