Section 1 – Summary and Recommendations

This report, which is required as a decision of Cabinet, provides a comprehensive summary of the consultation and engagement activity which has been undertaken in respect of proposed development of the Whitchurch Playing Fields, since November 2011.

Recommendations:

Cabinet is requested to:

- (1) Consider the feedback from the consultation and engagement activity summarised within the report, and
- (2) Agree that The Whitchurch Consortium should be commissioned to develop a community sport and leisure facility, at the Whitchurch Playing Fields, subject to agreement in respect of commercial terms.
- (3) Note that negotiations in respect of the Development Agreement, associated Service Level Agreement and Lease Terms will now commence, as previously authorised by Cabinet.
- (4) Note that the outcome of the negotiations will be reported to Cabinet for formal approval.

Reason: (For recommendation)

To attract inward investment to establish a modern sports and leisure facility, to include substantially improved playing pitches, for the benefit of the Community, at no direct financial cost to the Council.

Section 2 – Report

2.1 Introduction

This report summarises the consultation and engagement activity undertaken in respect of The Whitchurch Consortium's development proposals for the Whitchurch Playing Fields.

This report is presented in compliance with Recommendation 3 of the Cabinet decision, relevant to this matter, made on 17 November 2011.

The points below summarise the overall timeline to date relevant to the Whitchurch Playing Fields project:-

- November 2008 Cabinet confirms proposal to market The Whitchurch Pavilion and Playing Fields.
- June/July 2009 The Council's two preferred bidders give public presentations to local residents.

- November 2009 Council confirms that the project is postponed.
- November 2011 Cabinet confirms The Whitchurch Consortium as the Council's preferred bidder and authorises further consultation.
- 5 December 2011 Call-In Sub Committee Confirms Cabinet Decision
- 11 January 2012 Ward Councillor Consultation
- 23 February 2012 Ward Councillors' meeting with residents (Stanmore Library)
- 9 & 16 February 2012 Open Space Notice published
- 19 March 2012 Distribution of leaflets advising residents of the proposed project and arrangements for a Public Consultation meeting
- 26 March 2012 The Whitchurch Consortium Public Consultation
- 1 May 2012 Door-to-door Public Consultation commences, with distribution of Fun Day information leaflet
- 12 May 2012 The Whitchurch Consortium Fun Day
- 20 June 2012 Cabinet Report Consultation Feedback

2.2 Background

The Whitchurch Pavilion has remained vacant since it was fire damaged some eight years ago. Prior to this it was used as changing facilities, in connection with the adjacent playing fields. Whilst the sports fields are still used with aid of temporary changing facilities, they are not used as much as they could be and in any event are in poor condition requiring levelling and drainage improvements.

In November 2008, a report was presented to Cabinet setting out options available to the Council to secure the replacement or refurbishment of the Pavilion, the maintenance of the playing fields and the enhanced provision of sports, leisure and community use, through a Development Partnership Agreement, with a Private or Third Sector Partner.

Cabinet authorised the proposal and a marketing exercise commenced in 2009 seeking expressions of interest to the available opportunity. The Council proposed the grant of a lease for a thirty year period, with the tenant being responsible for the cost of refurbishment or for replacement of the Pavilion and the cost of improvement and all subsequent maintenance, together with the management and operation of the new facility.

After careful consideration two Preferred Bidders were selected. However, the project was postponed in November 2009, to enable further consideration of issues of concern which had been raised, in particular by local residents.

In 2011, consideration was given to resuming the project and following a careful review of the two Preferred Bidder's proposals and financial standing, Cabinet decided in November 2011 to select The Whitchurch Consortium as the Council's Preferred Bidder, who would then be in a position to take forward the necessary wide ranging consultation and engagement.

2.3 Consultation and Engagement

The information below is intended to provide a reasonably comprehensive summary of the consultation and engagement activity that has been undertaken in accordance with the November 2011 Cabinet resolution.

Ward Councillor Consultation Held 11th January 2012

The Whitchurch Consortium provided a full and thorough briefing on their proposals to the Belmont, Canons and Stanmore Park Ward Councillors. Eight Councillors attended the meeting and were advised that a Public Consultation meeting was to be arranged shortly.

Issues raised at the meeting included:-

- Lack of Ward Councillor consultation and the Council's handling of the project.
- The decision and delay in appointing the Council's preferred bidder.
- General proposals concerning the uses and the scope of development
- Proposed lease terms.
- Hours of operation
- The proposed SLA

It is understood that the Stanmore Park, Canons and Belmont Ward Councillors, separately arranged a public meeting at Stanmore Library on 23rd February 2012, to discuss the proposed Anmer Lodge development and the Whitchurch Playing Fields project.

Following this meeting the Corporate Director Place Shaping received twelve correspondences, regarding the Whitchurch Playing Field Project, including a letter from the Canons Park Residents Association. The main issues raised included:-

- Concerns regarding the lack of proper consultation
- The need to provide residents with information regarding the decisions which have been made by the Council
- Suggestions that the local rugby club should 'look after the playing fields'
- Suggestion that the decisions made by the Council 'fly in the face of the Localism Act and other policies'
- Proposals that local people should help to run local services and that assets should be transferred to enable this
- Concerns regarding the length of the proposed lease term
- Requests for information on how the project can be stopped

Publication of the Open Space Notice – 9 & 16 February 2012

The publication of the Open Space Notice resulted in two responses.

One respondent raised concerns about the disposal of the site without completing the planning process.

The second respondent submitted a very detailed objection, raising concerns in respect of consultation, the length of the lease, existing use, refusal of the Harrow Rugby Club proposal, the scale of development on the site and traffic related issues, with a clear request that the proposal is not allowed to proceed.

The Whitchurch Consortium Public Consultation 26th March 2012

Arrangements were made for The Whitchurch Consortium to present their proposals at a public presentation at Whitchurch School. There was publicity in the two week run up to the meeting, adverts being published in both of the local newspapers and a leaflet drop to approximately 4000 local residents, in the adjacent streets. **Appendix 1** is a copy of the leaflet distributed in the area surrounding the Playing Fields, together with a summary distribution record.

A PowerPoint presentation, provided at **Appendix 2**, was followed by a questions and answers session, with an audience estimated at 240, of which there were 131 recorded signatures.

Several senior Members of Council also attended the meeting.

Significant concerns were raised by local residents and the meeting became increasingly fractious. The information provided by the Consortium was limited, they were ill prepared to answer questions and appeared unable to articulate their proposals in an effective and detailed way. Consequently, the Community Organisations that had attended the meeting in support of the Consortium's proposals were unable to voice their support.

The meeting lasted approximately two hours and the main concerns raised at the meeting included:-

- Complaints that the Council had not consulted residents before deciding to resume the project and to select The Whitchurch Consortium as the preferred bidder
- The provision of incomplete and potentially misleading information to the meeting
- Concerns that inappropriate tactics were being used by The Whitchurch Consortium, which arose from wholly unnecessary references to potential retail and or nursing home developments on the site
- The hours of operation and the Licensed hours for sale of alcohol and public entertainment
- Noise and anti-social behaviour
- Suggestion that some weekends the site should not be used at all to give residents peace
- Traffic congestion and inconsiderate parking

- Vehicular conflicts arising from the proposed single access to the site to be shared with the school
- The size and location of the Pavilion
- The use of marquees and a failure to present a comprehensive overview of the proposed events, sporting and non sporting programme
- That no information regarding the proposed charges for the hire of the facilities was provided
- The adverse impact arising from a more intensive use of the playing fields
- Flood lighting overspill
- Flood alleviation potential to diminish the capacity of the flood plain
- Restrictions to public access
- Existing users dislodged
- · Adverse impact on property prices in the area
- Concerns that the leased term should not be greater than the thirty years referenced in the marketing information
- Potential assignment of the lease during its term
- That the consultation being undertaken was a sham and that the Council had already made its decision
- Concern that proposals received in 2009 were now out of date

For the avoidance of doubt, it was absolutely clear by the end of the meeting, that those present who had spoken at the meeting, and the majority of others who applauded many of the statements made, were robustly opposed to the proposals which had been presented by The Whitchurch Consortium.

At the presentation, residents were asked by the Corporate Director Place Shaping, to complete the available feedback forms and/or write to him by email at the Council expressing their views on the proposals.

Twenty seven Public Presentation Feedback forms were received and these are shown at **Appendix 3**.

Fifteen correspondences were received by the Corporate Director Place Shaping following the meeting. One of these contacts was supportive of the proposed development, whilst the other fourteen reiterated and emphasised the concerns which had been raised at the meeting, in particular disappointment in respect of the information provided at the Public Consultation.

Many of the emails received, included clear statements that the correspondent 'is against the proposed plans to develop Whitchurch Playing Fields'. This was augmented with many further statements that the proposal is 'against residents interests, over commercialises the area and duplicates provision provided at other nearby facilities'.

Other points made included:-

- A lack of clarity in respect of the proposed timeframe
- Concerns about litter and other pollution in the area

- The possibility for increased crime
- The proximity to houses and backgardens, of the Pavilion in particular, and the proposed pitch layout
- Why there is a need for the hospitality led facilities, in particular a function hall
- Suggestion that the proposal was an unacceptable change to the Planning Use Class
- Concern that the proposal would be detrimental to existing businesses in the area
- Concern that the project was being presented in a devious manner with material facts being glossed over

Further Officer Discussions with The Consortium

In view of the unsatisfactory and disorganised Public Consultation meeting, the Corporate Director Place Shaping called a meeting with the Consortium and The Portfolio Holder for Property and Major Contracts, at which he expressed significant concern regarding the presentation and the lack of preparation, in respect of questions which it would be reasonable to assume would be raised by residents at the meeting.

The Whitchurch Consortium confirmed their ongoing commitment to the proposal and their intention to commence a programme involving extensive door to door consultation with local residents and their suggestion to hold a Fun Day at the Playing Fields.

Door to Door Local Resident Consultation

In the week prior to the Fun Day, The Consortium carried out door to door consultation with local residents, providing more detailed information of their proposals for the Playing Fields and Fun Day. A copy of the information available to support these conversations is attached at **Appendix 5**.

Whilst conducting the door to door consultation 1,265 people signed a petition supporting the Consortium's proposals. A full copy of the petition has been provided to Cabinet Members.

The petition appears to show extensive support for the proposed development, however there are only seventeen signatories from the five surrounding streets of Wemborough Road, Abercorn Road, Old Church Lane, Cranmer Close and Green Verges. This further confirms that the residents immediately adjoining the site are particularly concerned about the adverse impacts that The Whitchurch Consortium's proposal will have for them.

At a meeting involving amongst others, the Chair of the Canons Park Residents Association and the Corporate Director Place Shaping on 23 May 2012, the Chair of CAPRA advised concerns in respect of the door to door to consultation. It is reported that The Consortium staff have presented a partial and misleading summary of the proposals for the site which has resulted in the signatures being obtained.

This view was reported to the Whitchurch Consortium's Project Manager, who has advised the Council in writing that; 'We have always endeavoured to present a fair and balanced view of the proposals to local residents. During our door-to-door consultation our staff were asked to describe the proposals of the project to residents, this included plans for the grounds, relocation of the pavilion and details of the facilities that will be created.'

Fun Day Saturday 12th May

Fun Day circulars publicising the event were hand delivered to local residents at the time of the door to door consultation and are attached at **Appendix 5**.

The Fun Day served four purposes.

- 1) To further raise awareness of the project and provide the opportunity for local residents to consult and have detailed discussions with Consortium representatives.
- 2) For The Whitchurch Consortium to demonstrate their ability to local residents to run effectively an event day far busier than that which would normally be anticipated with the new facility.
- 3) To demonstrate that The Consortium is listening to the concerns of local residents.
- 4) To provide an opportunity for community groups to demonstrate the services that they would like to offer the Community, from the Whitchurch Playing Fields.

The Fun Day was comprised of various sporting events including; junior football tournaments, youth volleyball tournament, Stanmore Scouts Group survival challenge, martial arts, pilates, yoga classes and a cricket tournament.

In addition, Consortium managers, technical staff, sports coaches and partner groups were available to discuss their proposals aided by extensive information which they had on display. **Appendix 5** provides an overview of the proposed development.

The Fun Day appears to have been a success enjoyed by approximately 800 people, many of whom were children and young people.

However, at a meeting on 7 June 2012, representatives of the Abchurch and Canons Park Residents Associations, advised that the event caused traffic chaos in the area.

Following the Fun Day the Corporate Director Place Shaping received two correspondence presenting further objections to the proposals. The key issues raised include:-

- Skepticism of the need for this commercialisation on Whitchurch playing Fields
- Lack of information on how the Pavilion, bar, restaurant and halls for hire would be used

- Events such as tournaments and weddings causing great disruption to residents
- Continuous stress on local residents from the seven day and late evening operation
- Traffic congestion and parking problems, including on minor side roads
- The need to separate the playing field and school entrances
- The proposed development should be located on a more appropriate site
- Concern that the Council is not taking sufficient account of local residents views
- Pressures from increasing school places, traffic, housing and other developments in the wider surrounding area
- Commercialisation of a highly valued green space
- No information in respect of the lease
- Concerns about the potential for trouble late at night as a consequence of alcohol consumption in the sport bar
- Noise and light pollution
- · Creation of an eyesore
- Loss of open space and unfettered public access

Petitions Received Against The Consortium's Proposals

- **1)** A petition was presented at Cabinet on 8th March signed by 161 local residents' and calls on the Administration to:-
- i) Restart the tendering process and not rely on information obtained in 2009
- ii) Fully consult with local residents, businesses and Ward Councillors regarding the selection of the preferred bidder

iii) Ensure residents concerns, regarding the impact on traffic, security, noise pollution and use of the Pavilion are addressed before proceeding with any development on the site.

A full copy of the petition has been made available to Members of Cabinet.

There appear to be approximately 15 signatories from the five surrounding streets of Wemborough Road, Abercorn Road, Old Church Lane, Cranmer Close and Green Verges.

2) A letter and attached petition dated 1st May was received on 9th May from two residents at Cranmer Close and expressed to be on behalf of residents at Cranmer Close, Old Church Lane, Abercorn Road, Wemborough Road and Green Verges (Marsh Lane) with a list (not signed) of 124 named persons who support the request for the Council to stop and reconsider the project in fairness to the residents of the surrounding streets.

A full copy of the letter and attached petition has been made available to Members of Cabinet.

The vast majority of the named supporters are from the five surrounding streets of Wemborough Road, Abercorn Road, Old Church Lane, Cranmer Close and Green Verges.

Response to Residents Concerns

At this stage the Council needs to determine if it wishes to confirm the agreement in principle, to enable the delivery of the Whitchurch Playing Fields Project.

Although residents have complained in robust terms regarding the consultation arrangements, it is clear that there has now been wide ranging engagement with residents and community groups.

Local residents have understandably raised reasonable concerns regarding the impact on their locality should this development proceed.

Assuming that a commercial agreement can be completed to take the project forward, the process of detailed planning can then commence. This part of the project will not only confirm precisely what is to be developed and provided on the site, but more importantly the measures that will be taken to mitigate the adverse impacts on the locality.

Applications for both Planning and Licensing will be required. Both of these separate processes require consultation and decisions will be made in public at relevant Committee meetings. The proposed development can only proceed if granted approval by the Planning Committee.

There is a significant shortage of quality playing fields available to the residents of the Borough. The Council is committed to working to increase opportunities for participation in sport and recreation. Modern day customer expectations require the provision of good quality facilities, which are well managed and maintained to ensure their long term viability. In these difficult economic times this often requires commercial solutions.

Emerging planning policy is that ancillary buildings should be appropriate in scale and not detract from the open character of the site. There will need to be further pre application discussions with planning officers to ensure that any Application is compliant with all relevant policy requirements.

In addition to any approvals given by the Planning and Licensing Committees, the Council as landlord will be in a position to enforce all relevant conditions through any lease term.

The points below are noted in response to some of the environmental issues which have been raised by residents.

Flood Alleviation

The Consortium has engaged at an early stage with the Environment Agency which will influence the design proposals and reduce hard surface areas to increase infiltration thereby reducing the level of surface runoff. Such measures will be essential and will need to be agreed with the Environment Agency as a Statutory Consultee for any Planning consent to be granted on the site.

The size and location of any proposed Pavilion will be heavily influenced by the Environment Agency's findings.

The Consortium are also considering imaginative steps to link the drainage on the site with an increased bio diversity area in the south western corner of the playing fields and immeadiately to the south of Edgware Brook which runs across the site. There is additionally proposed enhanced maintenance to the banks and vegetation along Edgware Brook.

Light Pollution

Subject to planning consent The Consortium expect in the winter, flood lighting on the all weather pitch to be extinguished by 10pm on weekdays. Modern flood lights are designed to minimise glare to surrounding areas and it is intended that this will be further reduced by the planting around any vulnerable residential boundaries.

After consultation with local residents the proposed orientation of the pitch and flood lighting has been reviewed so as to minimise further any adverse impacts to Wemborough and Abercorn Roads.

Sound Pollution

The Pavilion will be sited at a central location within the playing fields, with the clear objective of maximising the distance from as many residential properties as possible. The design of the Pavilion can further reduce noise concerns by having no windows in the elevation facing the closest boundary along Cranmer close.

All necessary noise reduction, including electronic limiters and automatic window closing will be incorporated within the building design.

Hours of Operation and Licensing

The Council's lease conditions will ensure that all relevant Planning and Licensing conditions in respect of hours of operation, will be capable of being easily and robustly enforced through the lease conditions.

Safety and Security

The Consortium proposes additional security through a 24 hour caretaker living on site and with repairs and upgrading of the existing boundary fencing. There is a further intention to install non intrusive CCTV to facilitate site wide operations.

Parking and Traffic Congestion

When considering any Planning application for a proposed development careful consideration will be given to all relevant traffic management implications. This will include the potential combined impacts arising from other previously approved developments eg Prince Edward Playing Field, to as to ensure the implementation of effective traffic management solutions.

Residents Consultation Group

The Whitchurch Consortium has proposed that a group comprised of local residents is established, to meet with the Consortium periodically as a forum for discussion, through any planning process.

2.4 Options considered

1) Continue Running the Site as it Currently Stands

The existing Pavilion structure is not safe. Estimated demolition and remediation costs for the Pavilion are in the region of £80K. Currently the Pavilion is costing the Council money in terms of keeping the site safe and free from vandalism. Additionally maintenance costs of the playing fields exceed income by approximately £5,000 per annum.

The 25 acre playing fields is under utilised and clearly has potential to provide good quality modern sports and leisure facilities.

Major drainage and general maintenance improvements at substantial cost are required, if the playing fields are not to continue to deteriorate.

2) Grant a Lease option with Service Level Agreement to the Council's Preferred Bidder, The Whitchurch Consortium.

The grant of a lease conditional upon rebuilding the Pavilion and improving the Playing Fields, together with a sports and leisure related SLA for the benefit of local schools and the local community, would result in a substantially improved sports and leisure facility at no cost to the Council.

3) Remarket the Property

Officers are of the view that there is no reason to believe that a stronger preferred bidder might emerge in the event that the Council chose to retender particularly in the current economic climate.

Furthermore such action could well result in the Council's preferred bidder choosing to pull out having to date expended substantial sums in good faith.

Recommendation

Officers recommend **Option 2** as being the best alternative to ensure substantial inward investment to provide new and substantially improved facilities at Whitchurch Playing Fields.

By entering into a partnership with The Whitchurch Consortium on a leasehold basis, the Council are able to control development of the site and influence the subsequent operation of the facility, for sport leisure and community related uses, at no direct financial cost to the Council.

The Planning and Licensing processes, combined with the lease terms, will ensure that any development will only be taken forward in a way which is sensitive to the impacts on the local community, whilst providing much needed modern sports and leisure facilities, to be available to the entire community of Harrow.

Community Safety

The Pavilion is a relatively large and currently derelict building, which whilst protected by a perimeter fenced, and continues to attract anti social behaviour.

Legal Implications

The Council has power under section 123 of the Local Government Act 1972 to dispose of land provided that the consideration is not less than the best reasonably obtainable. Where the land to be disposed off is or includes public open space, section 123(2A) of the 1972 Act imposes a requirement for notice of the proposed disposal to be published in a local paper for two consecutive weeks and any representations received to be considered by the authority before the disposal is concluded.

Under the General Disposal Consent 2003, if the Authority wishes, it can allow up to £2M reduction on the unrestricted value in the case of a potential user who will contribute to the achievement of the promotion or improvement of the economic, social or environmental well-being of the Borough or its residents.

2.5 Financial Implications

There are no direct financial implications to the Council which will result from this report.

However, if the Council decides to enter into a development agreement with The Whitchurch Consortium the general fund revenue costs, which supports the existing day to day operation and maintenance of the Playing Fields, will be saved.

Furthermore the Council will be able to avoid future capital costs associated with backlog maintenance, revenue costs associated with the ongoing security and demolition of the existing derelict pavilion.

The revenue implications resulting from the savings from the cost of maintaining the playing fields and impact on the hire of sports pitches in other parts of the borough are expected to be cost nuetral. The parking and traffic management policies around the area mentioned above, will be consider in line with outcome of the Councils parking review.

The risks around the consortium defaulting either during construction of the pavillion or thereafter needs to be duly considered and managed as part of the lease agreement. This will be considered in a separate cabinet report.

2.6 Performance Issues

The Council's corporate priorities will not be negatively impacted by any leasing arrangement.

Officers do not consider that the proposed change would have a significant effect on any Performance Indicators.

2.7 Environmental Impact

The proposals will lead to a greater intensification of use of the playing fields which will inevitably lead to issues relating to noise /light pollution increased traffic and concerns over the effect of development on a designated Environment Agency flood plain.

All the above matters will be considered and controlled through the Planning and Licensing processes and conditionality in the lease documentation although the proposal to locate the new Pavilion more centrally within the site away from the boundaries will help to mitigate many concerns.

2.8 Risk Management Implications

Officers do not consider that there to be any risk implications associated with this proposal.

2.9 Equalities Implications

By consulting with all interested community groups and by the preparation of informative tender documentation highlighting the requirements of an effective bid will ensure that all groups are treated fairly.

Whitchurch Consortium's mission statement as a community and sports organisation is to bring members of the local and wider community together by providing multi facility sports and leisure activities as well as educational and social opportunities.

The Consortium's vision is to have a community sports and social club accessible to all with no barriers to membership.

The proposals are consistent with Corporate Estate's existing Disposal of Property Policy and Officers do not consider that the disposal will have an adverse impact on any of the protected equality groups.

2.10 Corporate Priorities

The Proposal will not impact on any National Indicators, BVPIs or KPIs but this action will contribute to improving the management of the Council's Assets; both Use of Resources and Comprehensive Area Assessment require the Council and its partners to demonstrate improvement and innovation in Asset Management.

In terms of the Council's Corporate Priorities the report's proposals and recommendations contribute to:-

- Keeping neighbourhoods clean, green and safe.
- United and involved communities: A Council that listens and leads.



- · Regeneration of the playing fields by installing new drainage, levelling and reseeding
- Construction of a new community hub at the centre of the playing fields, with a range of eco-friendly and sustainable features
- Secure the perimeter fencing, install extra surveillance cameras and have 24-hour on site security
- Address current flooding issues, by consulting with the EA, planting more trees, easing flow of the stream and creating a natural pool as a possible containment
- Reducing current traffic issues by creating an extra 150 parking spaces, looking at the option of another entrance on Marsh Lane, installing secure cycle racks and promoting less car usage
- The community hub will be open to all, with a nominal lifetime membership fee and provide facilities such as cafe, restaurant/bar, gym, training room, function/sports hall, health and beauty clinic, child care centre etc
- Invite local businesses and start-up companies from Harrow to run different aspects of the hub



HA21 comments on Whitchurch Playing Field

Response to Consultation Questionnaire

1. What is your greatest concern about the facilities currently provided at the Whitchurch Playing Fields and what improvements do you feel are urgent and pressing?

The presentation states "old pavilion is derelict and unfit for purpose". This is a euphemism, and fails to state that the condition of the pavilion is the consequence of years of neglect. All buildings can be kept serviceable if there is the will to do so, and their internal services can be modernised — often the most economical procedure. Harrow Council neglected the pavilion and drainage on the site for many years, hence is obliged to opt for demolition and replacement — a more costly option, but the only one open to us.

The damage caused by the years of neglect needs to be reversed, and the site should continue in use as a playing field, with the grass area substantially retained, with proper provision for changing and refreshments for the teams playing there (but see 2 below).

2. What needs of residents should the proposed development of the Whitchurch Fields seek to address?

Blake Hall's sports centre in Wanstead is surrounded by woods, a lake and Wanstead Golf Course. Its website describes it as secluded. It has direct access to the A114 and A116, and has no housing nearby. This location is able to host events up to 2 a.m. or later, without causing any disruption to the neighbourhood from music at the events or from traffic leaving them.

The differences between the Whitchurch Playing Field and Blake Hall at Wanstead are substantial, and the successful business model at Wanstead with evening and late events is not appropriate for Whitchurch, as it is certain to cause severe disruption to a much more populated neighbourhood.

Whitchurch Playing Fields are surrounded by housing, and the proposed access is from Wemborough Road, whose residents are already inconvenienced by school runs to Whitchurch School. Abercorn Road residents have the same experience with Stanburn School. Harrow Council require schools to produce School Travel Plans but these make no difference to pupils' travel arrangements. Consequently residents have no confidence in the undertakings given when developments take place as they can see they are never fulfilled. An undertaking was given at the meeting that the opening hours for the sports complex would not coincide with school travel times – this is credible for the morning but unrealistic for the afternoon.

Harrow Highways dept. has identified safety concerns and have ruled against access to the proposed complex from Marsh Lane, but there was the suggestion at the meeting that this could be reversed. The lane that gives access from Marsh Lane is 2.9m wide – with verges 8.8m – very inadequate as access for a busy site.

The concerns residents have are traffic, noise and disturbance from the pavilion with events at first floor level till a late hour, and disturbance as participants leave.

3. What specific sports would you like to see made available at the Whitchurch Playing Fields and the new pavilion in the future?

The existing grass area lends itself to football, cricket, hockey, rugby and a grass running track. A floodlit astro pitch could accommodate football or hockey – would need careful location, good lighting and proper management to prevent any nuisance. Tennis courts? Bowling green? Badminton, squash, basketball inside?

Site could host borough or school sports days, Harrow Marathon, St. Luke's Hospice run.

4. What specific non sporting activities would you like to see made available at the Whitchurch Playing Fields and the new pavilion in the future?

Consider the fields are suitable to host Under One Sky (which is homeless now the Kodak sports field is scheduled for development).

Stanmore Baptist Church have held holiday clubs in the fields - this use could resume.

Suitable for Scout or Guide camps.

Welcome creation of woodlands and eco area, composting and educational area, but the proposal includes dog walkers. If the dog owner is disciplined and cleans up dog mess, and if the activity is restricted to the woodlands area, then it can be managed reasonably, but exercising dogs is incompatible with a sports field – sportsmen should not be expected to come into contact with dog mess. This will need proper management!

What arrangements are proposed for access by pedestrians? Desirable for Sai School, Baptist Church and 1st Stanmore Scouts to have convenient pedestrian access (as they are some distance from the Wemborough Road entrance – probably be necessary to restrict times these entrances are open to reduce the risk of unsocial behaviour.)

5. Do you have any specific concerns about the proposals that have been listed above. In what ways could these concerns be modified or reduced?

We welcome the proposed use of a permeable surface and Grasscrete for the car park and overflow car park, and the provision of cycle racks.

However we note that of the 17 local supporting organisations listed, only 4 have easy access to the site – the remainder will need to travel from other parts of the borough or beyond, and are likely to do so by car.

We are concerned about the basement in the pavilion, which is certain to affect the water table and to risk flooding in the neighbourhood. Whitchurch School experienced flooding early in its life, and the character of the area is obvious - part of Stanmore Marsh and adjoining Marsh Lane.

The illustration showed the pavilion with a standing seam metal roof. It should be possible to install photovoltaics — would certainly be desirable to do so — a building in regular use is best able to benefit from this technology. Possible use of heat pumps in the building? Rain-water harvesting, or re-use of grey water?

A problem that has not been recognised to date is that Barnet Football Club intend to move to the Hive (formerly Prince Edward Playing Fields), ½ mile away along Whitchurch Lane. Barnet are a Football League club in Division 2, and plan to move after the 2012-3 season. It is possible to gain access to the ground from Whitchurch Lane, but it is not clear whether this entrance will be permitted, encouraged, discouraged or banned. Hence it is impossible to tell whether there will be football traffic in Whitchurch Lane, which will conflict with traffic to the Whitchurch Playing Fields. Has this potential difficulty been recognised?


PROPOSED EAST ELEVATION


It should be noted that these plans are indicative at this stage.






PROPOSED WEST ELEVATION

STRATEGY

The park is a place for the community. The security and safety of its users, most especially that of our children, is the most important aim we can accomplish in this project.

Through consultation with the school and nusery, we understand that the environment needs to be both protective of, and enhancing of childrens' lives.

The boundary conditions will employ fencing, natural planting and entrance gateways to ensure that the site can be controlled to prevent anti social behaviour and the safety of our members.

A members' card will allow selective access to the park. With access points around the whole perimeter, this will help reduce the volume of traffic going to Wemborough Road.

Pedestrian access is key to helping create a convenient environment. Dog walkers are welcomed and will be given membership through an open book policy. This will require their cooperation to clean up any mess and so numerous bins will be provided, however it may be necessary to continually review access rights to maintain cleanliness and safety of others.


CCTV will be employed as discretely as possible to help disuade antisocial behaviour, and create a secure environment. The landscaped terrain will have sensor controlled path lighting, bins, and appropriate signage helping keep the area accessible to people of all ages. The aim is to create an environment which people can enjoy using and have pride in, without any fear to their safety.

There will be a caretaker on site at all opening times and possibly further security.

A security strategy will be negotiated with local police to incorporate their crime prevention advice.

The intended demolition of the existing pavillion will create a large area which will support 130 new parking spaces. These will be accessed upon immediate entry through the existing gateway or from the existing parking spaces. Used infrequently, the area will be made from grass-crete - a permeable and semi natural grass surface. This will allow water infiltration and importantly create the appearance of a continuous green landscape, which will seemingly reduce the impact of built surfaces on the site.


A shuttle bus service will be implemented to reduce the level of car traffic.

Car sharing will be encouraged for fans and players who will use the site, further aleviating the level of traffic.

The existing pavement and access areas will be re-surfaced to give entrances greater visibility for pedestrians and motorists. Car parking areas will be raised to pavement areas to create a shared surface. Shared surfaces are proving to reduce motorist speed and increase the awareness of both drivers and walkers thereby reducing accidents. Routes will nevertheless be clearly demarcated to direct flows of traffic.

If you ask any young people and people who work with young people whether they want such a facility the answer will be YES. I am in scouting for a long time and in UK for more than 20 years and I hope my expectations are reasonable."

Answer:

Firstly, I can easily understand why the young people that you represent would be supportive of our plans for the Whitchurch Playing Fields site.

Although a substantial proportion of Harrow is made up of open space, only a relatively small amount of this is available for publicly accessible sports pitch use and, unfortunately, many of these pitches are not of the quality that our local sports men and women, boys and girls require, or expect, in the 21st Century.

The cost of establishing and maintaining high quality sports pitches is substantial. During these exceptionally difficult economic times it has become even more difficult for the Council to directly fund the development of essential sports infrastructure.

So the Council has turned to private sector partners to see if they can provide the resources to enable us to ensure that our residents can have access to high quality modern sports facilities.

So one of the reasons these things take so long is because of the need to ensure that everyone has a chance to have their say.

Assuming that Cabinet this evening decides to commission the Whitchurch Consortium to take the project forward, I will ensure that the detailed planning process is undertaken in a robust way.

It is crucial that we do not rush this next phase, rather

that we get it right and, as part of this, that we ensure the widest possible involvement in the formal consultation process which will be undertaken by the Council's Planning and Licensing Services.

Consortium's plans to mitigate this by having increased grasscrete parking spaces, cycle racks, shuttle services and pedestrian entrances will go a long way to addressing these issues, but how will the Council work collaboratively with The Consortium to address the traffic

issues further?"

Written Answer:

I am acutely aware of the concerns that have been raised by residents who live in very close proximately to the Playing Fields, regarding traffic related issues.

The Whitchurch Consortium are required to submit a detailed planning application before taking forward proposals and when these further details are received by the Council, a comprehensive review of the traffic and parking issues, will be undertaken by specialist officers, as part of the Council's assessment of the application. It is at this stage that the Council will determine if traffic management interventions are required.

In respect of existing parking pressures in the area, I am advised that a review of parking in the vicinity was conducted earlier in the year, and a detailed consultation on the introduction of "at any time" waiting restrictions at junctions along Wemborough Road, is scheduled as part of the Council's work programme.

What assurances are there that the interests of immediate local residents will be protected from the effects of increased traffic, and nuisance from the many visitors to the pavilion late into the evenings and weekends and all

day events?

(There will be constant pressure on the lives of local

residents 24/7)."

Answer: Firstly, I wish to make clear in the most robust way possible, that no aspect of this project will be 'rubber

stamped'.

I hope you agree that this evening's report has

presented a reasonably balanced view of the issues and concerns which have been raised by local residents in particular.

The planning process is a formal regulatory function which is quite independent of the day-to-day or commercial business management functions of the Council.

If commissioned to take this project forward the Whitchurch Consortium will be required to submit a detailed planning application to enable the new facilities to be established. The Planning Committee will determine the application at a public meeting. Planning officers will undertake formal consultation with residents and the product of this consultation will be reported in an impartial and objective way to the Councillors, who are Members of the Planning Committee.

Additionally, the Licensing Committee will consider any application submitted to it quite independently of all other Council functions and public consultation will also be required as part of this process.

As part of its applications, the Whitchurch Consortium will need to demonstrate how they will act to manage any identified adverse impact for the local community.

Having considered all material issues the Planning and / or Licensing Committees may place conditions to ensure appropriate management of the new facility and to minimise impact for residents.

The officer report makes clear that the commercial negotiations relevant to this project will be reported to a future meeting of Cabinet for formal approval. This is another example of the care that the Council is taking in respect of this important and sensitive matter.

I would like to assure all residents that there will be no rubber stamping on any issue relevant to this matter. There will only be the most careful consideration of all material issues at each point in the decision making process.

Supplemental Question:

This is just another extra lot of traffic and extra development that is in the area amongst lots of other developments. We cannot ignore the fact that Stanburn School, which is next door, is going to have quite a large increase in pupils. Is it going to be considered by alongside this application? There is a large amount of traffic going to be created by that.

Answer:

Supplemental As part of any planning application, they have to submit a Travel Plan and the Planning Committee will consider all traffic impacts during their deliberations and they will make a decision on their own, independent of any other Council officers.

Question: "I have three children who play football on Whitchurch

Playing Fields and consider this site to be unsuitable, as it currently does not have any essential amenities. Our Club, St Joseph's FC, are fined by the Middlesex Football Association each time we have a league match

on this site as we do not have any changing rooms.

Harrow Council have not been able to provide such amenities and I understand that this has been due to the lack of finances. Whilst I am happy for another organisation to take over this site as these playing fields are not being maintained and attract unsocial behaviour (such as fires being started in the old pavilion, littering, alcohol, broken glass), my question is:

Will there be adequate toilet facilities, including female and male changing rooms as part of the new

proposals?"

Yes, there will most definitely be adequate toilet facilities Answer:

and changing rooms.

The Council is working to establish a modern sports facility and it is essential that the 'club house' provides superb changing and welfare facilities because this is what our sports men and women, boys and girls, require and expect.

Although the club house will provide a range of ancillary facilities, I know that the Whitchurch Consortium understand that the primary purpose of the building is for the provision of necessary welfare facilities to directly support the use of the outdoor sports pitches.

Questioner: Himat Gami

Asked of: Councillor Thaya Idaikkadar, Deputy Leader and

Portfolio Holder for Property and Major Contracts

Question: "The Corporate Director Place Shaping has clearly

chosen to ignore the strength of feeling in the March consultation meeting in which the residents were strongly against the proposals. He is recommending these proposals as the Council wants to off-load their responsibility. It's a bit pointless collecting signatures from people who are not going to be affected by the changes. It is rather irrelevant that other sports clubs are in support so long as "it's not in my back yard". We have a massive Harrow Leisure Centre in our Borough

and this is adequate.

My question to the Portfolio Holder is how many people are in favour of the proposal whose back garden actually

falls into the Whitchurch Playing Fields?"

Answer: I cannot agree that the report ignores the views of residents who are against the Whitchurch Consortium's

proposals.

The report which Cabinet will consider this evening contains clear and objective summaries of the issues and concerns that have been raised by residents.

On page 247 of the report (the penultimate paragraph) there is a clear statement which reads '... residents immediately adjoining the site are particularly concerned about the adverse impacts that the Whitchurch Consortium's proposal will have for them.'

The same paragraph states that only seventeen signatories from the adjoining streets have shown support for the proposal.

I can quite understand why the residents whose homes are located on the streets immediately adjoining the site are most concerned about this proposal. I am really sympathetic to your views.

However, the Council has to consider the needs of the entire borough. We have a severe shortage of good quality outdoor sports facilities. This project has the potential to improve this situation.

The Council will also do all that it can to ensure that any

adverse impacts for the local community are minimised.

Supplemental I still did not hear from your answer how many people from the signatures that were collected, whose back garden falls into the Whitchurch Playing Fields, actually said "Yes"?

Answer:

Supplemental I have already said in my answer there are seventeen signatures from the adjoining streets.

Question: "In a recent discussion with residents the Whitchurch Consortium boasted that it had visited some 4000 houses as part of its consultation. Given that most houses have more than a single occupancy, the 1200 signatures on the Consortium's petition was obtained from less than 20% of the people the consortium visited, are you willing to accept that the majority of residents in the area object to the consortium's selection as is

constantly represented by residents to the Council?"

I accept and fully understand that a significant number of residents in the area are concerned about the Whitchurch Consortium's proposals for the Whitchurch Playing Fields site.

The key issue for the Council is that majority of our outdoor sports pitches are of inferior quality and we need to do everything reasonably possible to provide modern high quality facilities for the entire community of Harrow.

The Whitchurch site is comprised of twenty two acres which has been designated and set aside for sports playing field use.

Our sports men and women, boys and girls, need to be able to develop their skills on good quality pitches. Good quality pitches supported by modern ancillary facilities, will also in my opinion, encourage greater participation in active sport and recreational activities. I hope that you can support the Council's efforts to do everything possible to enable appropriate sports facilities development to be taken forward in an appropriate way, always ensuring due consideration for the impact on local residents.

Answer:

Although I fully appreciate the concerns of residents whose homes are associated close to the site, you have my assurance that the Council will do everything reasonably possible to ensure that disruption and inconvenience is minimised.

I hope that you can understand that our overriding objective is to ensure the provision of good quality sport and leisure facilities for the entire community of Harrow.

Question:

Supplemental It does sound like you have made up your mind. Why has the Council not actually engaged in the consultation and left it for the bidder to blow its trumpet with figures that are fictitious at best, rather than go out there and listen first hand to local residents. You proclaim to be the Council that listens and are you going to listen tonight because I am not sure that you are from your answer?

Supplemental Answer:

I do not accept that they do not listen to you. A sports open day, was designed to show people the maximum impact. The pitch was changed by 90° and they were planting more trees to cover the flood light effect. There are so many things they are doing. This is only the beginning. There is a long way to go, then we have to negotiate how we commercially agree on that and they are going to consult you and we are going to consult you on that. We are always going to do our best to make sure any inconvenience caused to you is minimal.

Question: "I understand that the Council has to get best value for

money for Harrow Residents, but surely there are also other Government directives to local Councils, to consult and work with local communities to obtain their views and to take these views into consideration when making

decisions.

How do Harrow Council ensure these two directives are compatible and how will you put this into operation in relation to Whitchurch Playing Fields?"

As I have stated in responses to previous question, our Answer:

overriding objective is to ensure the provision of modern high quality sports and leisure facilities which are

available for use by our entire community.

We have not yet commenced the detailed commercial negotiations relevant to this project. What we have done is concentrated on engagement, in particular with the residents who live closest to the Whitchurch Playing Field site.

In so doing we have been able to obtain a clear and comprehensive understanding of, in particular, local concerns and this feedback will be incorporated within the detailed planning for the development and operation of any new facility.

Our commercial negotiations will be undertaken to ensure that 'Best Consideration' can be demonstrated. In so doing we will aim to strike an appropriate balance between total capital investment, lease term, subsidised access, charging policy and site utilisation.

You will understand that there is a balance to be found between each and all of these elements and crucially impact on the local community will be a key overarching consideration when determining the final agreement.

Question: "By commissioning Whitchurch Consortium to develop

and run the sports and leisure facilities on the site you are committing yourself to granting the necessary licences for liquor and late night entertainment, without which the project would not be viable. The Consortium would not have pursued the project this far without assurances from the Council that the licences are only a formality. Will the contract with Whitchurch Consortium include written guarantees regarding noise, opening hours, light pollution and anti-social behaviour etc. and

will the Council withhold the licence, if necessary?"

Answer: The Council has given no commitment whatsoever

regarding the grant of licences. We cannot do that and

it is illegal.

As I stated in my response to Mr Read's question earlier, the Licensing function operates quite

independently of all other Council functions.

Assuming that we complete a Development Agreement with the Whitchurch Consortium, a planning application is approved and the development is constructed, there is guarantee that a licence will be automatically.

The Licensing Committee has wide ranging powers of determination from refusal of the licence to granting with conditions.

Assuming that any applications are approved, it is likely that in determining the application that both the Planning and Licensing Committees will impose appropriate conditions. It would be understandable if the Planning and Licensing Committees incorporated conditions, in respect of noise, opening hours, external lighting and anti-social behaviour.

These conditions will be incorporated within the Lease Contract thereby providing the most robust controls possible.

Any person has rights to ask the Council to review a licence at any time if the facility is not being managed in an appropriate way.

Supplemental Question:

Given the fact, as Mr Pais originally asked in his question about the business case being founded upon the licence function to enable them to hold social functions within the pavilion, there seems to be issues when you go through all the paperwork about security and so forth, extra work that is going to be required; how is the business case stacking up with all these extra costs with the necessity to have a major function hall at the pavilion to fund everything? Have you looked through it and have you looked through the business case to satisfy yourself that, in fact, what they are proposing is not basically a function hall with some community sports but is, in fact, community sports with just merely a bar.

Answer:

Supplemental I have no idea what the Licensing Panel is going to do. If they say "no alcohol", the agreement may break down. The bidders may simply walk out. We have to operate on the reasonable expectation assumptions which may not work. We just have to wait and see. It is going to be many months before the financial model is refined, revised and see whether it is workable or not.

Question: "In its Cabinet decision to proceed to award preferred

playing fields remains viable?"

Answer: Assuming that Cabinet commission the Whitchurch

Consortium to take the project forward, the necessary detailed commercial negotiations will now commence.

As part of these negotiations the Council will require the Whitchurch Consortium to present a revised Business Plan and to demonstrate that it will be commercially

viable over the term of the plan.

Prior to making the decision at Cabinet in November 2011 to appoint the Whitchurch Consortium as the preferred bidder, Council officers had undertaken a financial review. This will be repeated again at various stages until such time as the lease is finally completed.

Question: "The draft DPD submission that is being considered

tonight emphasises that "the site is suitable for community outdoor sports use only" and that "development will be restricted to the minimum necessary to support outdoor sports use, and must not prejudice the role of this site as a flood storage area." What restrictions are you proposing to limit redevelopment of the pavilion by the Whitchurch Consortium to prevent it being used as a venue for social events rather than community sports and have you considered the impact of the proposed all-weather pitch on the role of the site as a flood storage area?"

Answer: The size and use of the pavilion will be considered at the

planning application stage and appropriate conditions applied, to ensure that the proposed development is

consistent with the Site Allocations Development Plan Document and other planning policies relevant for the site

The Development Agreement and Lease will provide an absolutely clear link with any planning permission. The Lease will also require the Council's explicit approval before any planning permissions are submitted in the future. The Council as Landlord will need to agree that it is prepared to accept the submission of the planning application, prior to any consideration by the Planning Committee.

The layout of the site, including the all-weather pitch, has been developed in discussion with the Environment Agency. Further discussions will be undertaken with the Environment Agency on the location and impact of all of the different components of the proposed scheme prior to the submission of the planning application, to guide the drainage strategy for the site, maintain flood storage capacity and determine any measures that may be required to mitigate the risk of flooding elsewhere.

Supplemental Question:

Mr Trehern's letter to the Ombudsman does not mention the Environment Agency once. So when is this consultation by the Environment Agency going to take place, when according to the Ombudsman it should have happened some while back. Would you not agree?

Answer:

Supplemental You mention Mr Trehern's letter which I have not seen, so I cannot respond.

Andrew Trehern:

There is an ongoing Ombudsman investigation so I think it will be appropriate to maintain the correspondence between the Council.

Mrs Lewis' question clearly stated the Planning Policy context for this important sports facility.

I can therefore answer your question with a high degree of confidence that planning permission will only be granted for the development of this site if the Planning Committee is confident that the primary function of the playing field site remains 'outdoor sports use'.

Supplemental Question:

I would like to ask, given the incompetence of the Consortium's presentation on 26 March and the fact that they run Blake Hall which is in an isolated location and hosts events up to 2.00 am or later, has direct access to 'A' roads and no housing nearby, how do you consider that this a suitable company to be running this very different site and that they are competent to do this?

I hope Harrow Council has reserves in the bank for when residents sue Harrow Council for their neglect of duty to its residents when we are flooded because they have displaced all the water somewhere else.

Answer:

Supplemental There are two questions there. Whitchurch Consortium did not say they are going to run the facility exactly how they are running in Wanstead. This is a different location; they are going to run it separately. This is the whole idea of this development agreement. The officers and they will sit down and make sure everything is going the right way and that it is appropriate for that location.

> local residents, why are you pressing ahead with awarding the Whitchurch Consortium with the contract to develop Whitchurch Pavilion and Playing Fields, when the paper before Cabinet tonight makes it abundantly

clear local residents don't want this to happen?"

The Council has been thinking about opportunities to Answer:

improve the Whitchurch Playing Fields for many years.

In fact, the background selection of this evening's report clearly states that Cabinet considered the matter in November 2008

You are also aware of the poor quality of most of our outdoor pitches, and the time has come, even in this challenging economic period, to see what can be done to provide improved facilities for our sports men and women, boys and girls. I really do hope that you can support me in this endeavour.

The Whitchurch Playing Fields is a substantial site and therefore has a borough-wide strategic significance. Given its playing field designation, it is wholly appropriate that we consider this site for development as a modern, high quality, sports and leisure facility.

However, and this is a really important issue for myself and my colleagues on Cabinet, any development of improved sports and leisure facilities which we agree to take forward on this site is only approved once we are entirely satisfied that the disturbance and inconvenience to local residents has been minimised.

The very last thing that we want to achieve is a wonderful new sports and leisure facility at the expense of our local residents' enjoyment of their homes.

As I have said in responses to questions from members of public, the Council has to take a borough-wide view. We will do everything possible to find a good and appropriate balance between the needs of our sports users and local residents.

Supplemental Question:

Is it not a fact that when the Consortium did present at the public meeting, you described the presentation as flawed and failed to make a case, that there was an outcry at the meeting by the residents about how poor it was. Is it not a fact that residents have repeatedly raised questions, as they have done tonight again, about the impact it will have on their lives. Is it not a fact that the report does not give weight to the residents in the immediate locality.

Answer:

Supplemental As I said before, we need to look at it Borough-wide. We are not looking at just the local area.

Questioner: Councillor Barry Macleod-Cullinane

Asked of: Councillor Thaya Idaikkadar, Deputy Leader and Portfolio Holder for Property and Major Contracts

Question:

"In the DPD paper that went to Overview and Scrutiny on the 12th June, it explicitly ruled out any housing being permitted on the Whitchurch Pavilion and Playing Fields site. How is this compatible with the Whitchurch Consortium proposing 24-hour live-in caretaker/security on the site, why haven't you as Portfolio Holder noticed this restriction and ruled this facility out, and what would the impact on the business case be of ruling this facility out?"

Answer:

I am advised that your question at Overview and Scrutiny Committee related to the Site Allocations Development Plan Document. Your query is recorded on page 8 of the Cabinet Supplemental Agenda 2 which is the reference from Overview and Scrutiny Committee.

I assume that your query relates to the statement on page 252 of the Cabinet papers, under the section 'Safety and Security'.

The statement reads 'The Consortium proposes additional security through a 24 hour caretaker living on site and with repairs and upgrading of the existing boundary fencing. There is a further intention to install non intrusive CCTV to facilitate site wide operations.'

The Site Allocations DPD is absolutely clear and I quote from page 146 of this evening's Cabinet papers:

'The site is currently open space and is an important recreational destination. The site is suitable for community outdoor sports use only. Development will be restricted to the minimum necessary to support outdoor sports use, etc'.

Local residents have raised concerns about anti-social behaviour on the site as it exists today and about ongoing site security, if the Whitchurch Consortium's proposals are implemented.

Clearly the deployment of a site manager or caretaker, who is resident on the site, could be part of a broader security plan as referenced in this evening's Cabinet papers. However, the introduction of a residential unit on the site may be controversial and sensitive from a planning policy perspective.

At this stage as the Cabinet report states 'The Consortium propose'. That is all we have at this stage – an initial outline suggestion and I understand that other

similar facilities use a similar approach to good effect.

If the Whitchurch Consortium wish to include this proposal as part of their detailed planning application for the site, this will be subject to determination by the Planning Committee.

Supplemental Question:

In terms of the proposal by Whitchurch Consortium to build what they described as a bungalow on the site. probably next door or on top of the Tesco's that they were proposing on the site, could you explain to me, have you gone through the covenants that relate to the land to check whether or not any of this is entirely within their proposals and in keeping with the paper and the decision tonight?

Answer:

Supplemental Barry, there is no mention of Tesco's anywhere. I have not seen it. There is no mention of a bungalow. What they are proposing, as part of the pavilion there would be some sort of accommodation for the caretaker, related to his job.

> This is their proposal only. In the development stages we will look at it again and this is a proposal made some time ago. The Planning Committee has the final authority to say whether they will get planning permission or not.

447. **Key Decision - Whitchurch Playing Fields**

Cabinet received a report of the Corporate Director Place Shaping, which provided a comprehensive summary of the consultation and engagement activity which had been undertaken in respect of proposed development of the Whitchurch Playing Fields, since November 2011.

The Portfolio Holder for Property and Major Contracts was of the view that, if approved, the proposal would provide excellent facilities for people of all ages. The Portfolio Holder added that the consultation had been wide and that he was grateful that the site was being considered for development after many years. He added that this was only the second stage of the process and that many other considerations would be necessary before any development on the site could go ahead. Moreover, there were no guarantees that the development would go ahead. He assured that the proposal would not be 'nodded' through without robust and careful consideration. He commended the report to Cabinet.

The Corporate Director Place Shaping stated that the Whitchurch Playing Fields site was of strategic significance to the borough. The Corporate Director explained the consultation process following approval by Council in November 2011 and the feedback received following engagement with residents. He added that all Members of Cabinet had previously received the

petitions received in relation to the proposals, including that organised by the Whitchurch Consortium in support of the proposals.

The Corporate Director added that this was the second stage of the process and that the report was impartial and comprehensive and had captured the key issues made by residents. He was of the view that the proposals would not adversely impact on the residents and that the object had been to manage, mitigate and minimise the impact on both the local community and the borough as a whole. The Council would have failed if the development would result in creating an adverse impact on the community.

The Corporate Director added that, if the proposals were approved, the Whitchurch Consortium would be expected to undertake pre-application consultation prior to the submission of a planning application, which would be considered by the Council's Planning Committee. He added that the planning process was an independent one.

The Portfolio Holder for Children, Schools and Families was of the view that the proposal would create a legacy for future generations and that the young people of Harrow, who often felt that they were not listened to, would particularly benefit from the creation of a sport facility. The Council had an opportunity to develop a facility for families to use, and he expected the various processes to be approved independently.

The Portfolio Holder for Community and Cultural Services stated that a recently conducted survey by the Council had shown that only 15% sport pitches were rated as good or excellent. The proposals from the Whitchurch Consortium would help improve this figure and he alluded on the support received from the various colleges, scout groups and sporting organisations to this investment in the borough during an Olympic Year. The Portfolio Holder added that it was important that the Council listened to the concerns of the local residents but at the same it had a vision to fulfil which was to improve the facilities in the borough. The Planning and Licensing processes were independent and he expected the applications from the Whitchurch Consortium to be analysed with vigour.

The Portfolio Holder for Adult Social Care, Health and Wellbeing referred to a letter of support from Age Concern which would also wish to use the facilities. She added that older and disabled people would also benefit from the proposal.

The Leader of the Council referred to the work that previous administrations had done to bring the Whitchurch Playing Fields into use. He added that further reports would be submitted to Cabinet, including the Development Agreement, and that many issues had to be resolved before the proposals were brought to fruition.

RESOLVED: That, having considered the feedback from the consultation and engagement activity summarised within the report:

- (1) the Whitchurch Consortium be commissioned to develop a community sport and leisure facility, at the Whitchurch Playing Fields, subject to agreement in respect of commercial terms;
- (2) it be noted that negotiations in respect of the Development Agreement, associated Service Level Agreement and Lease Terms would now commence, as previously authorised by Cabinet.
- (3) it be noted that the outcome of the negotiations would be reported to Cabinet for final approval.

Reason for Decision: To attract inward investment to establish a modern sports and leisure facility, to include substantially improved playing pitches, for the benefit of the Community, at no direct financial cost to the Council.
