## **PUBLIC NOTICE 2**

### **CABINET 10 APRIL 2014 AT 6.30 PM**

Pursuant to Regulation 10 (3) (a) & (b) of the Local Authorities (Executive Arrangements) (Meetings and Access to Information) (England) Regulations 2012, notice is hereby given that the Council's Cabinet proposes to take a Key Decision at the meeting of a Cabinet to be held on Thursday, 10 April 2014 in relation to:

#### **Whitchurch Playing Fields – Free School**

*[This report relates to the disposal of Whitchurch Playing Fields to an academy trust for the purpose of establishing a new Free School on the site.]*

The reason why compliance with Regulation 9 (1) of the Local Authorities (Executive Arrangements) (Meetings and Access to Information) (England) Regulations 2012 was impracticable is

- (1) at the time of the publication of the April Key Decision Schedule, it could not have been envisaged that the decision relating to Whitchurch Playing Fields would be required, as it was not known exactly when the Education Funding Agency would be able to confirm their requirement for the site.
- (2) it is essential for the Council to make a decision relating to Whitchurch Playing Fields in order to allow the Education Funding Agency to meet their tight timescales.

The Chairman of the Overview and Scrutiny Committee has been informed in writing of the matter about which the decision is to be made.
