Pursuant to Regulation 10 (3) (a) & (b) of the Local Authorities (Executive Arrangements) (Meetings and Access to Information) (England) Regulations 2012, notice is hereby given that the Council's Cabinet proposes to take a Key Decision at the meeting of a special Cabinet to be held on Tuesday, 28 May 2013 in relation to:

#### **Future Organisation of Cannon Lane First School (4-7 Years) and Cannon Lane Junior School**

*[This report relates to a matter that was previously on the agenda for the 9 May 2013 Cabinet meeting, which was subsequently cancelled.]*

The reason why compliance with Regulation 9 (1) (c) & (d) of the Local Authorities (Executive Arrangements) (Meetings and Access to Information) (England) Regulations 2012 was impracticable is

(1) At the time of the publication of the Key Decision Schedule, it could not have been envisaged that the 9 May 2013 Cabinet meeting would be cancelled and that its membership would change;

(2) it is essential for the Council to make a decision relating to Cannon Lane First School and Cannon Lane Junior School, as (i) the Council must determine the proposals within two months of the representation period, which ended on 18 April 2013 and (ii) the schools need certainty around the position for 1 September 2013.

The Chairman of the Overview and Scrutiny Committee has been informed in writing of the matter about which the decision is to be made.
