**Question:** Please could you dispel the myth that your administration is claiming to invest in services to support our residents, when in actual fact national failures and bad decisions on the economy from the Conservative Government are leading to the council being reactionary with our budgets contributing to excessive pressure on public services and rising council taxes.

**Question:** Harrow desperately needs more special needs provision. There are now greater numbers of children and young people with SEND and complex needs. By 2025, 180 additional places will be needed and by 2029, this rises to 330 places.

The Government chose not to approve our bid for a Special Free School (292 places) despite the clear evidence of need in the borough.

I note the increase in ARMS and temporary provision, but residents will be left wondering about long term plans.

I understand there have been discussions in recent weeks with the Dept of Education, could the Portfolio Holder update us on the outcome of these discussions and let us know when Harrow will get the special needs school it desperately needs?
